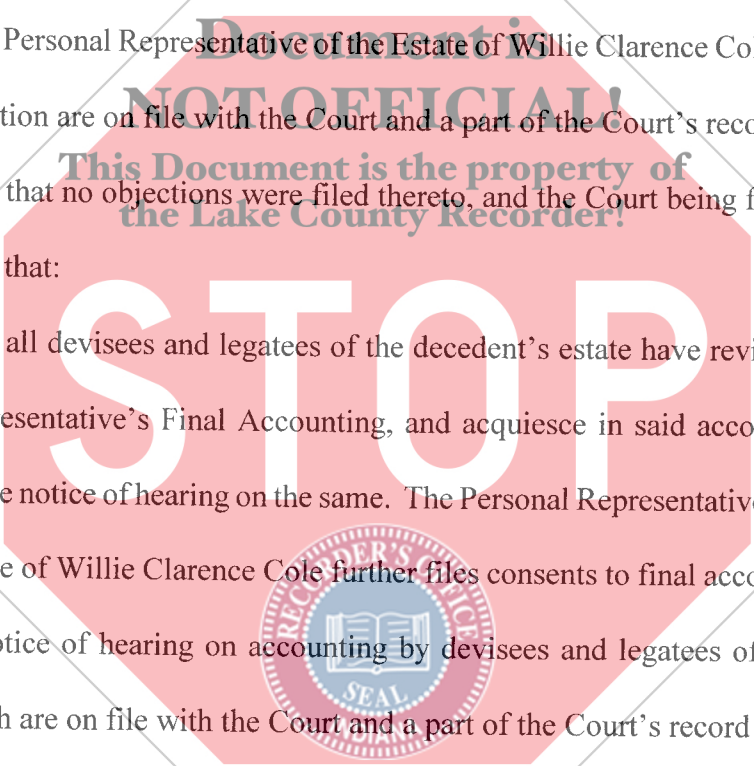
**ORDER APPROVING PERSONAL REPRESENTATIVE'S FINAL REPORT AND ACCOUNTING, PETITION TO ALLOW ACCOUNTING, PETITION FOR ORDER APPROVING DISTRIBUTION AND CLOSING ESTATE**

This cause came to be heard on the 26 day of JUNE, 2008, upon the Final Accounting, Petition to Settle and Allow Account and for Authority to Distribute Estate filed by Tiyauna R. Cole, as Personal Representative of the Estate of Willie Clarence Cole, deceased, which accounting and petition are on file with the Court and a part of the Court's record.

It appearing that no objections were filed thereto, and the Court being fully advised in the premises now finds that:

1. That all devisees and legatees of the decedent's estate have reviewed the Personal Representative's Final Accounting, and acquiesce in said accounting and further waive notice of hearing on the same. The Personal Representative of the Supervised Estate of Willie Clarence Cole further files consents to final accounting and waiver of notice of hearing on accounting by devisees and legatees of decedent's estate which are on file with the Court and a part of the Court's record
2. That Willie Clarence Cole died intestate a resident of Lake County, State of Indiana, on the 29<sup>th</sup> day of August, 2007, and said Personal Representative was issued Letters of Administration on the 9<sup>th</sup> day of November, 2007, and since that date she has continued to serve in such capacity.

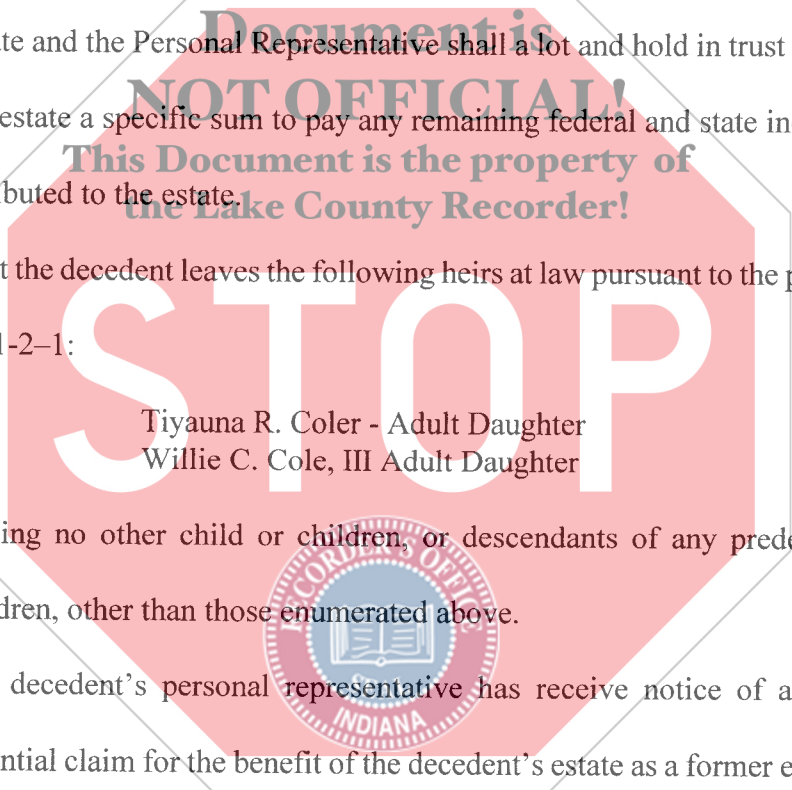

3. That the matters and things stated in said accounting and Petition are true and said Personal Representative has accounted for all assets in this estate coming into his hands.
4. That more than three (3) months have elapsed since the date of the first published notice to heirs and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his Personal Representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; and all estate taxes, inheritance taxes, and gross income taxes, if any assessed in said estate, have been paid. The Personal Representative further represents that a final fiduciary return will be filed on behalf of the decedent's estate and the Personal Representative shall a lot and hold in trust for the benefit of the estate a specific sum to pay any remaining federal and state income taxes to be attributed to the estate.
5. That the decedent leaves the following heirs at law pursuant to the provisions of I.C. 29-1-2-1:  
Tiyauna R. Coler - Adult Daughter  
Willie C. Cole, III Adult Daughter  
leaving no other child or children, or descendants of any predeceased child or children, other than those enumerated above.
6. The decedent's personal representative has receive notice of a contingent and potential claim for the benefit of the decedent's estate as a former employee of U.S. Corporation and decedent's Personal Representative shall continue to pursue said claim on behalf of the decedent's estate through this proceeding.
7. That the decedent owned a piece of real estate located at 3995 Louisiana Street, Gary,



Lake County, Indiana, at the time of his death, more particularly described as follows:

The South 20 Feet of Lot 27 and all of Lot 28, in State Park Addition to Gary, as per plat thereof, recorded in Plat Book 12, Page 9, in the Office of the Recorder of Lake County, Indiana. Tax Key No. 47-123-28.

and that said real estate shall be transferred and titled in the name of the decedent's surviving children, Tiyauna R. Cole and Willie C. Cole, Jr., as tenants in common each with an equal one-half (1/2) interest in said real estate.

**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** by the Court as follows:

1. Said Final Report and Accounting of said Personal Representative is hereby in all things approved, settled and confirmed.
2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution should be made pursuant to the distribution set forth in the final accounting and is hereby in all things approved including the Personal Representative's allocation for payment of final federal and state fiduciary income taxes on behalf of the decedent's estate.
3. That said Personal Representative is hereby directed to distribute and pay the balance of the Estate in her hands for distribution as follows:

Tiyauna R. Cole - Adult Daughter	\$120,445.21
Willie C. Cole, Jr. - Adult Son	\$120,445.21
4. That the decedent owned a piece of real estate located at 3995 Louisiana Street, Gary, Lake County, Indiana, at the time of his death more particularly described as follows:

The South 20 Feet of Lot 27 and all of Lot 28, in State Park Addition to Gary, as per plat thereof, recorded in Plat Book 12, Page 9, in the Office of the Recorder of Lake County, Indiana. Tax Key No. 47-123-28.

and said property shall now vest and be titled in the names of Tiyauna R. Cole and Willie C. Cole, Jr., as tenants in common each with an undivided one-half (1/2) interest in said real estate and further the Personal Representative is ordered to record a copy of this Court's Order in the County where said real property is located.

5. That the Personal Representative is authorized to continue to pursue on behalf of the decedent's estate a contingent claim against United States Steel Corporation in the name of the decedent which involves a claim for unpaid wages and further the Personal Representative is authorized to retain the services of attorneys necessary to bring suit on behalf of the decedent's estate under the Fair Labor Standards Act and said estate remain open for the specific purpose of pursuing this claim on behalf of the decedent's estate and the Personal Representative shall make due report of any monies recovered on behalf of the estate.

6. Said Personal Representative is hereby directed to file her Supplemental Report showing that she has complied with the terms of this Order and said Personal Representative has in all things carried out the provisions of this Final Decree.
