That she is an adult and the surviving spouse of DONALD G. THOMPSON, who died on January 13, 2006.

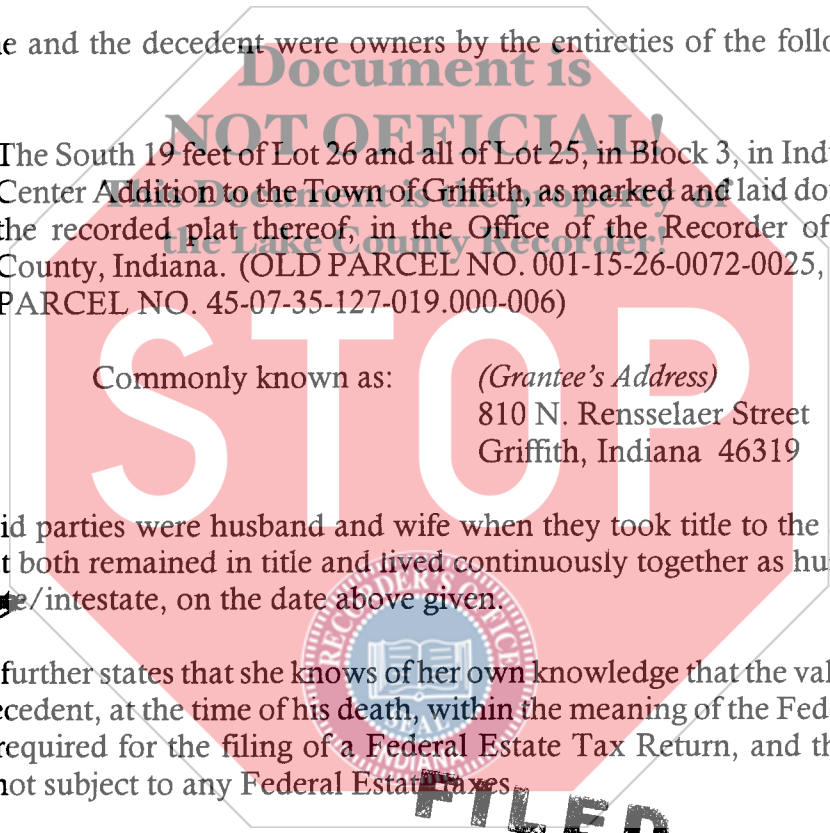
That she and the decedent were owners by the entireties of the following described real estate, to wit:
