# TAX DEED

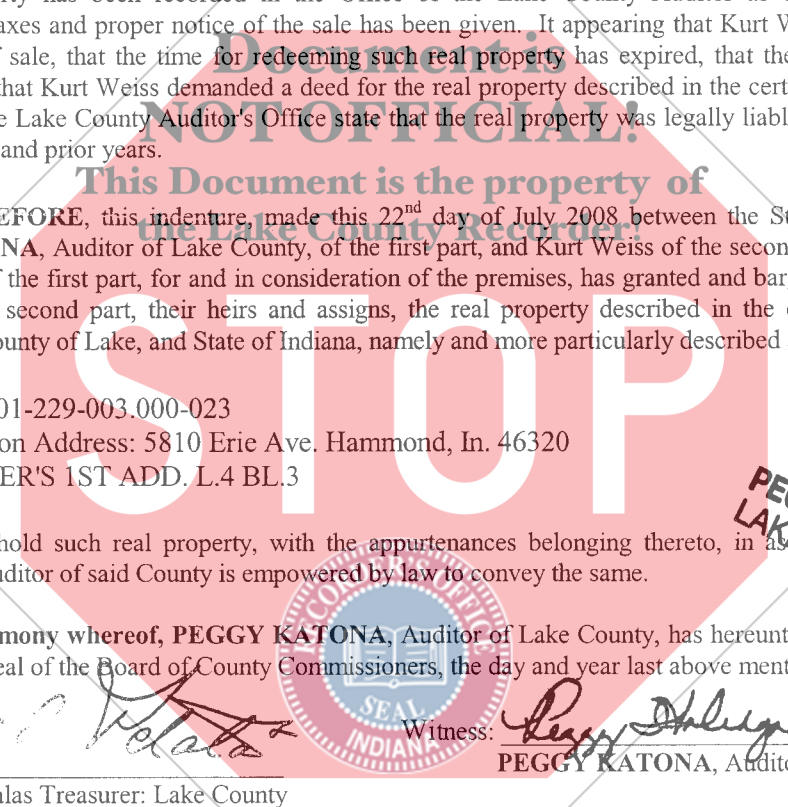
