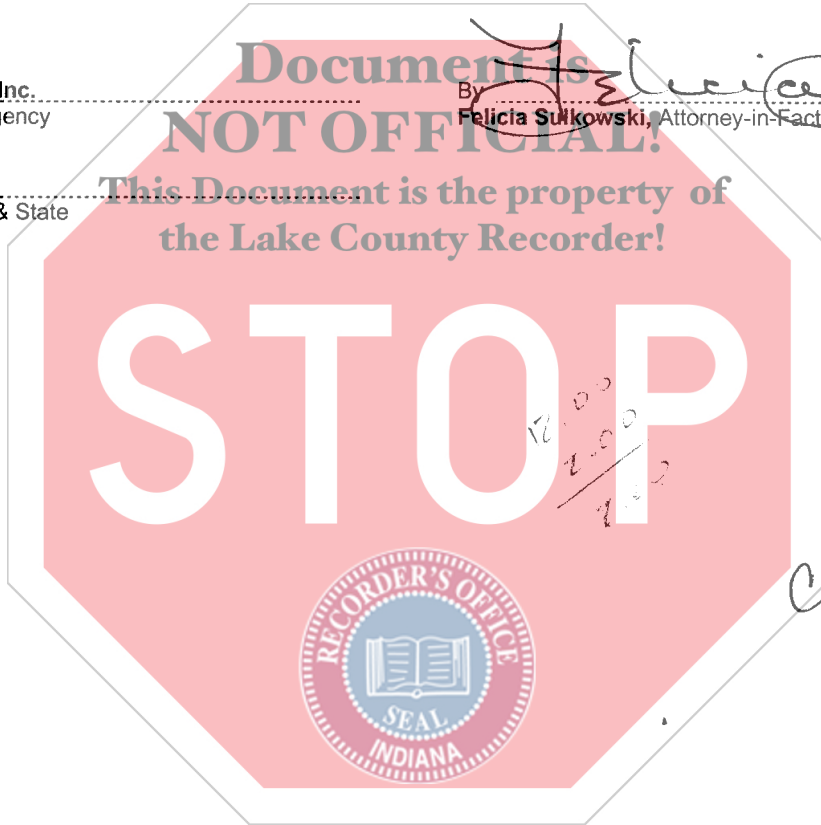

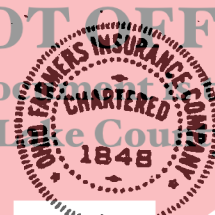

Corporate Seals Affixed



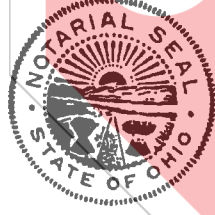
