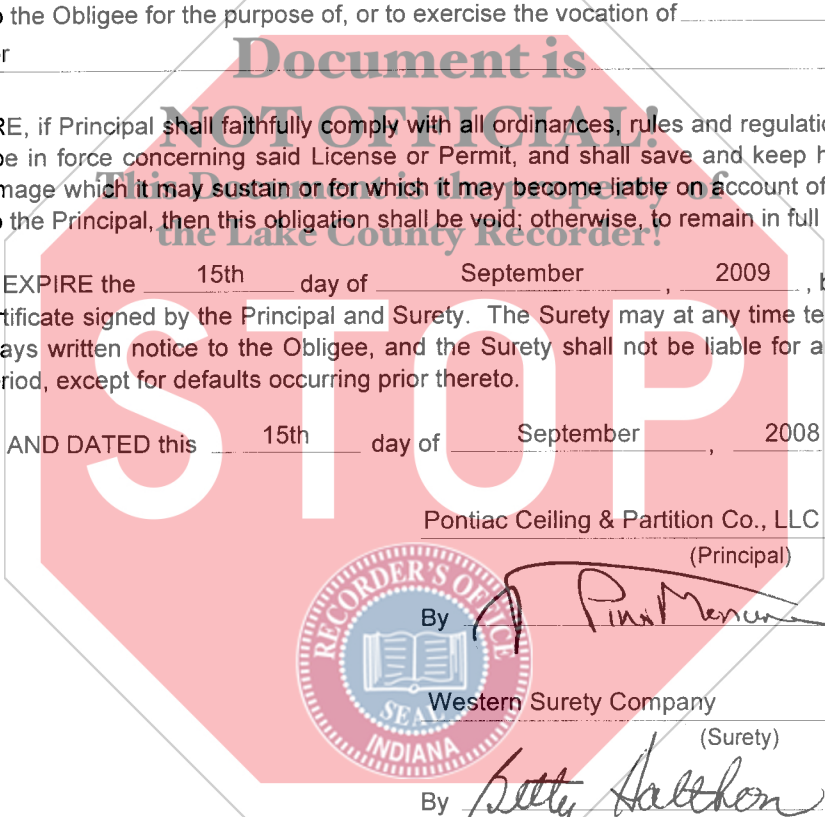

Authorizing By-Law
