2. That your Affiant and **William A. Sullivan** were duly and legally married at the time they acquired title as husband and wife to the following described real estate:

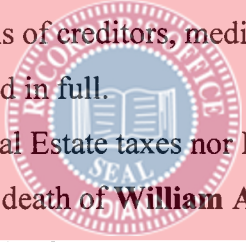
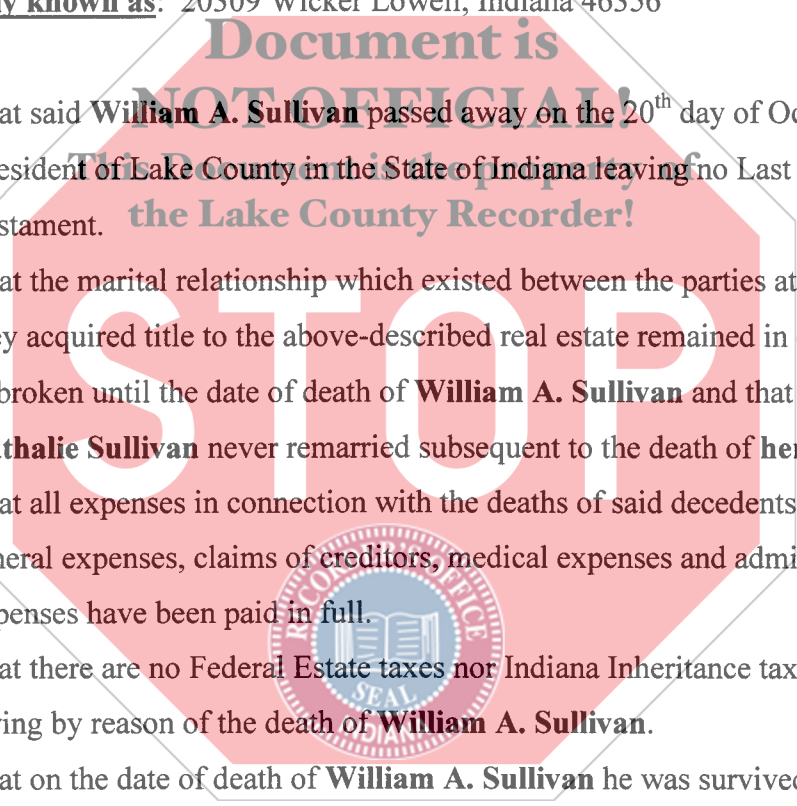
