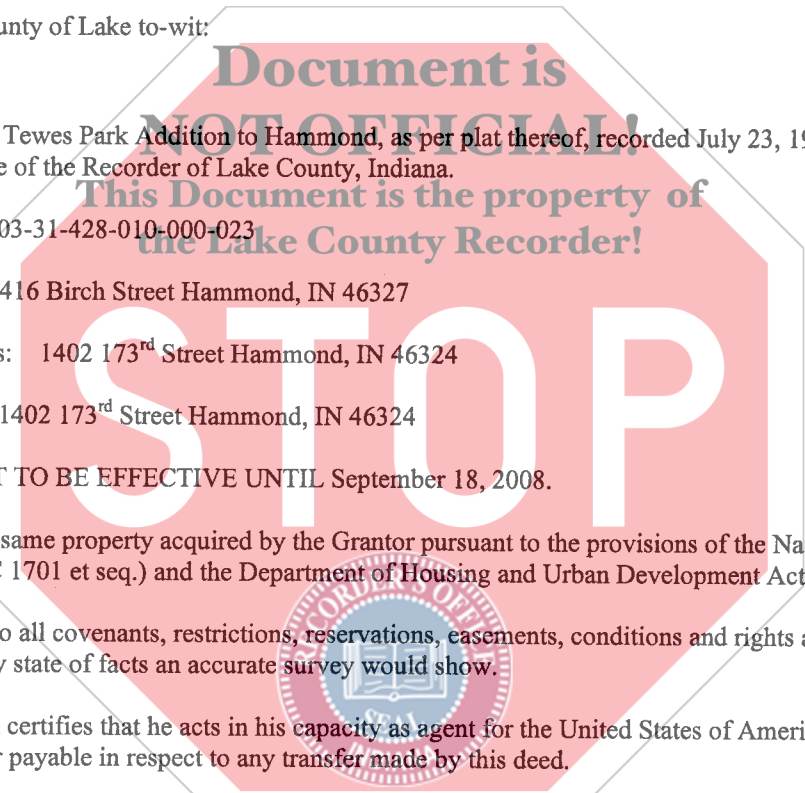
THIS DEED IS NOT TO BE EFFECTIVE UNTIL September 18, 2008.
