General Contractors License

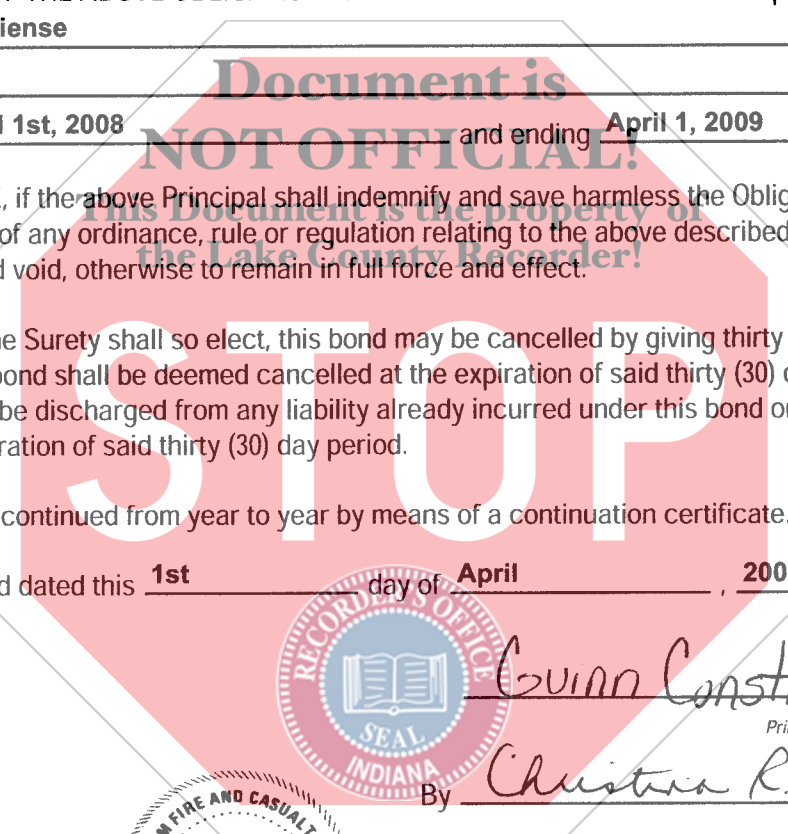
for a term beginning April 1st, 2008 and ending April 1, 2009
