**TRUSTEE'S DEED**

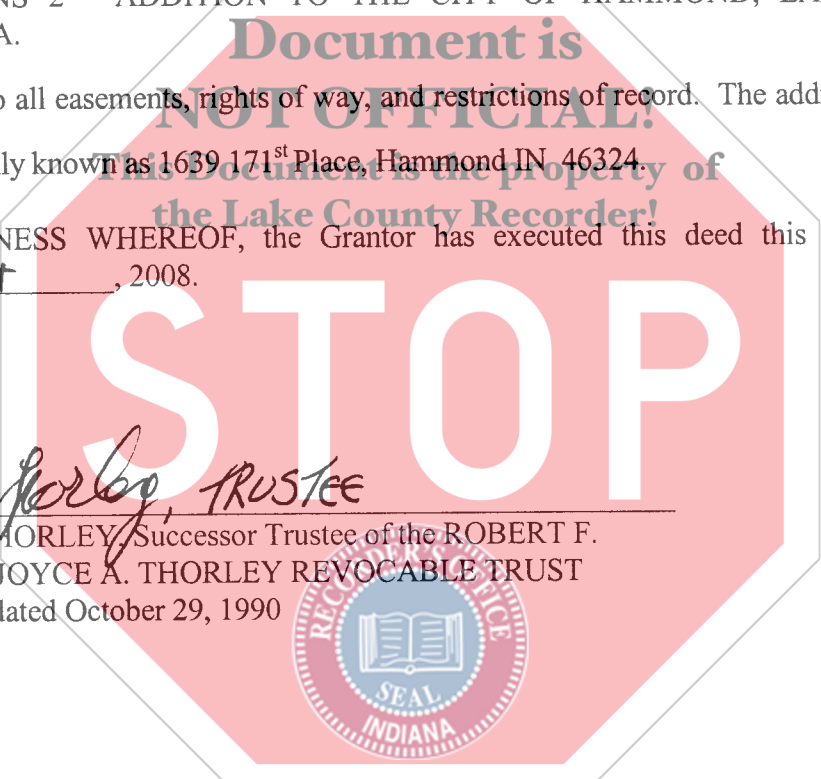
