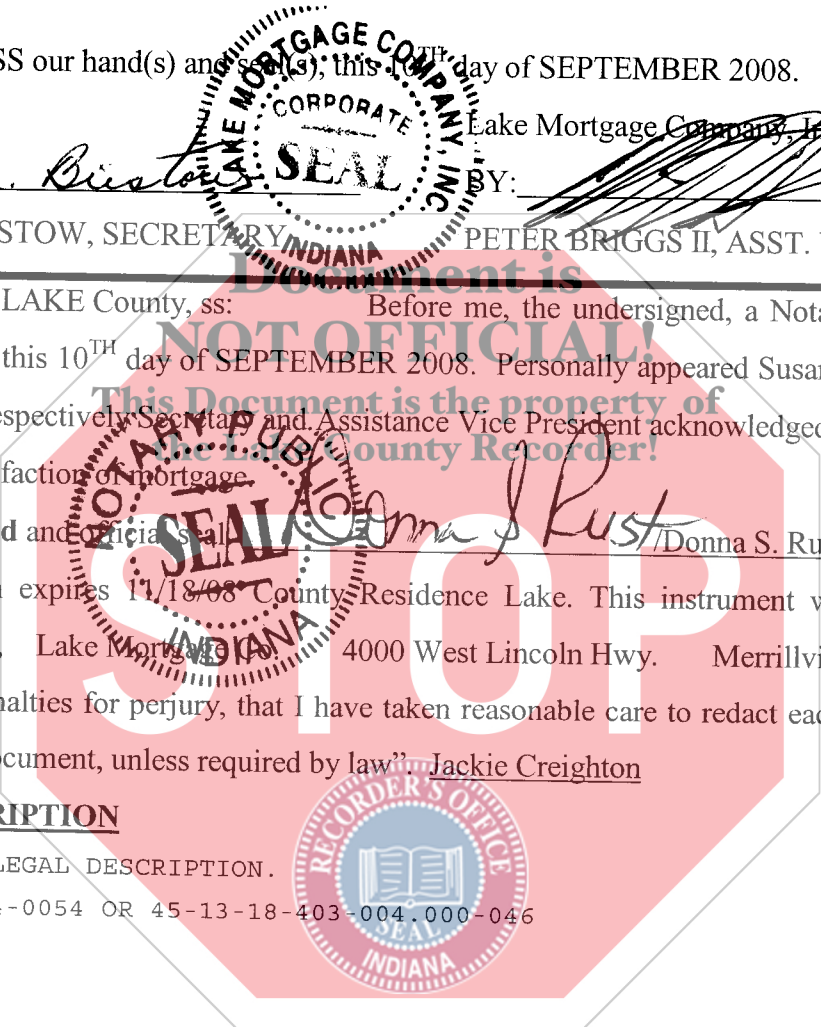

RIDER - LEGAL DESCRIPTION
