MACIEJEWSKI and each being duly sworn upon her oath and states as follows:

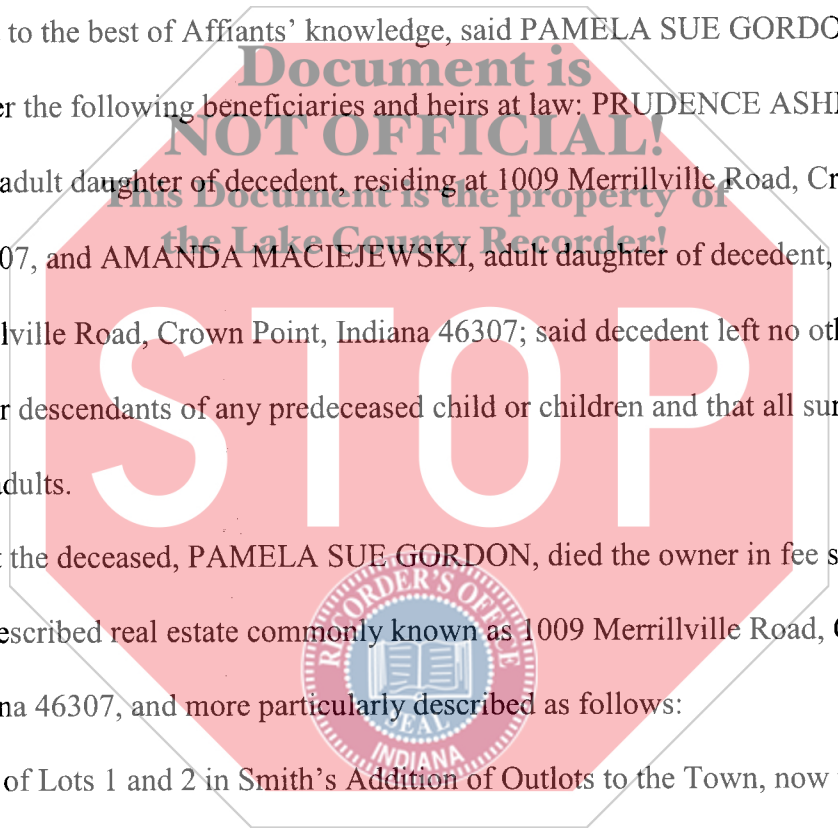

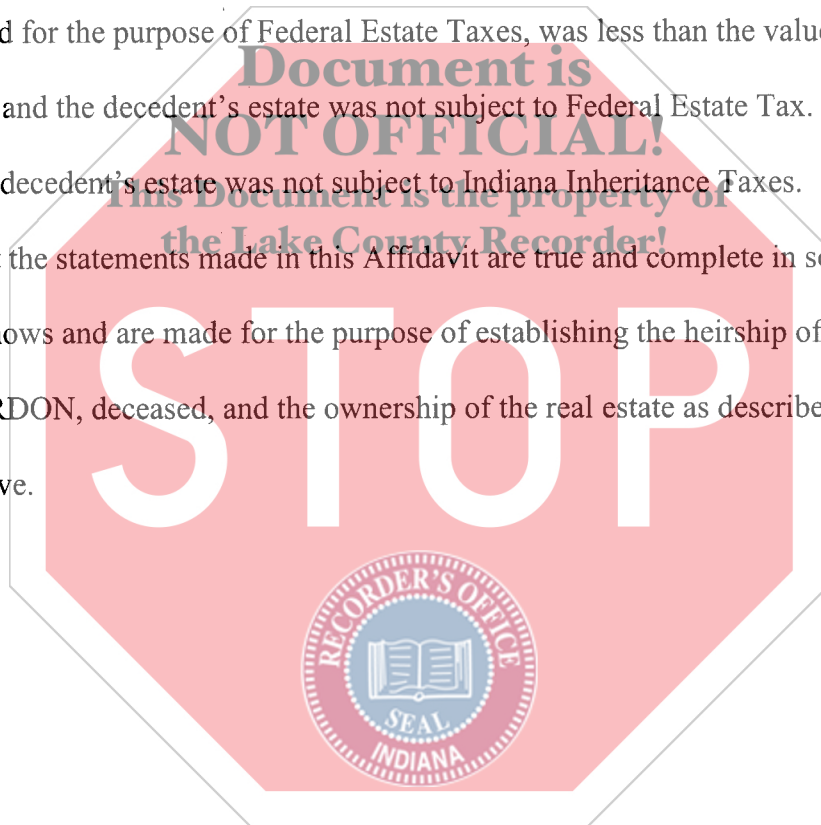

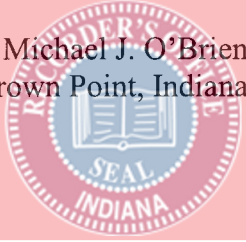
