# POWER OF ATTORNEY

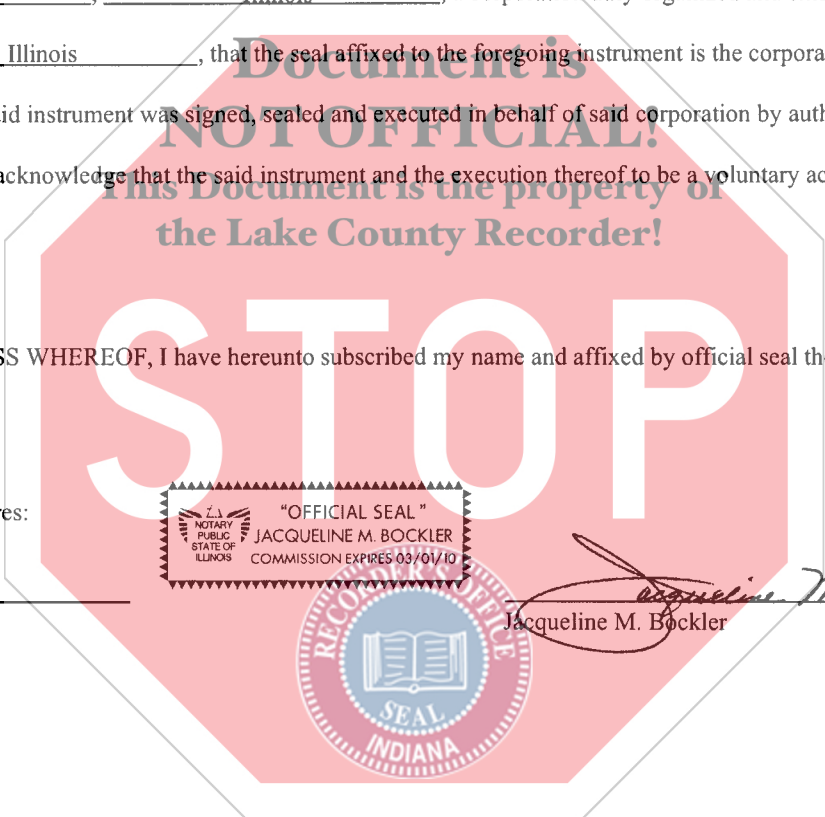
