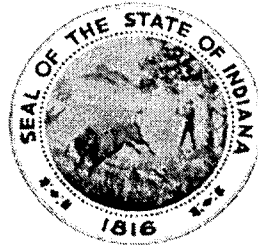

INDEMNIFYING MORTGAGE

THIS INDENTURE WITNESSETH THAT Lois Sinder
Of Lake County, in the State of Indiana, as Mortgagor(s), mortgage and warrant to North Township of Lake County, 5947 Hohman Ave. Hammond, IN 46320, a political subdivision of the State of Indiana, the following real estate in Lake County, State of Indiana, to wit:

Common address: 5118 Reading Ave. East Chicago, IN 46312

Legal description: Kosciusko park Addition Lot 24 Block 3

Together with the rents and profits there from, to secure the payment, when the same shall become due, of the following indebtedness: the sum of \$ 7,575.83 Dollars the same being amounts due, and payable for repayment of poor relief benefits from the period from 11/1/07 to 2/13/08, not otherwise satisfied by resources of the mortgagor or having been earned by reason of workfare contribution under the poor relief laws of the State of Indiana.

Upon failure to pay said indebtedness upon demand, then said indebtedness shall be due and collectable, and this mortgage may be foreclosed accordingly or otherwise enforced with reasonable attorney fees, court costs and expenses of litigation. It is further expressly agreed that, until said indebtedness is paid, the mortgagor will keep all legal taxes and charges against the real estate paid as they become due, and will keep the building thereon insured against fire and other casualties in an amount at least equal to the indebtedness from time to time owing, with loss payable clause in favor of the mortgagee, and will, upon request, furnish evidence of such insurance to the mortgagee, and failing to do so, the mortgagee may pay said taxes or insurance and the amount so paid, with eight percent (8%) interest thereon, per annum, shall become a part of the indebtedness secured by this mortgage.
