KNOW ALL MEN BY THESE PRESENTS:

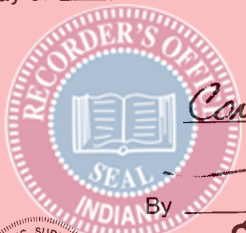
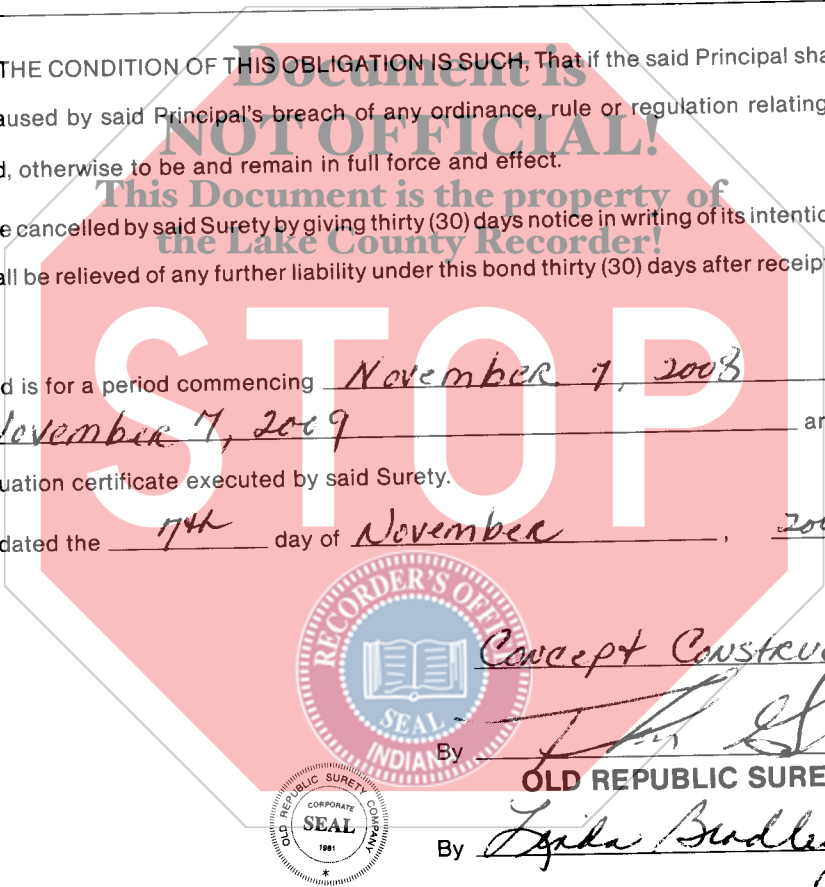
WHEREAS, the said Principal has applied to said Obligee for a license to or permit as a General Contractor

This obligation may be cancelled by said Surety by giving thirty (30) days notice in writing of its intention so to do to said Obligee; and the said Surety shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by the said Obligee.

The term of this bond is for a period commencing November 7, 2008 and terminating November 7, 2009 and may be continued from year to year by continuation certificate executed by said Surety.

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That OLD REPUBLIC SURETY COMPANY, a Wisconsin stock insurance corporation, does make, constitute and appoint:

This Power of Attorney is signed and sealed by facsimile under and by the authority of the following resolutions adopted by the board of directors of the OLD REPUBLIC SURETY COMPANY on February 18, 1982.
