## ORDER ON STIPULATION AND AGREEMENT

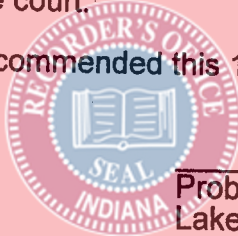
Co-Petitioner, **RODNEY K. RICH, RODNEY K. RICH, II, ERIN LOTTINO**, and **JULIE LOTTINO**, by counsel, David E. Mears, and Respondent, **THOMAS RICH**, by counsel, John W. Peters, having filed their stipulation and agreement, which is in the following words and figures, to wit: (H.I.)

The court having examined said stipulation and agreement and being duly advised in the premises now approves the stipulation and appointment of **RODNEY K. RICH** as Successor Trustee of the Rich Joint Trust dated June 6, 2002, as amended on May 15, 2003 (hereinafter referred to as the "Rich Joint Trust").

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

1. That the Court now orders the Rich Joint Trust docketed and that the Court has jurisdiction over the parties and subject matter.
2. The Court now approves the Stipulation and Agreement of the parties (H.I.)
3. That **RODNEY K. RICH** shall serve as Successor Trustee of the Rich Joint Trust upon taking and filing an Oath of Successor Trustee with the court.
4. That **THOMAS RICH** has Thirty (30) days through and including June 12, 2008 to file his accounting with the court.

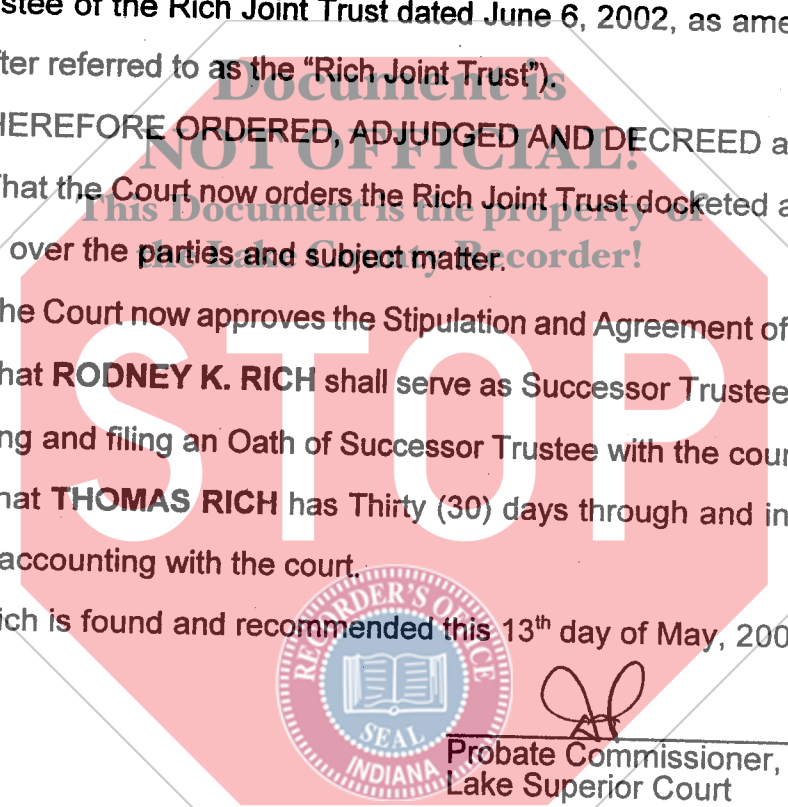
