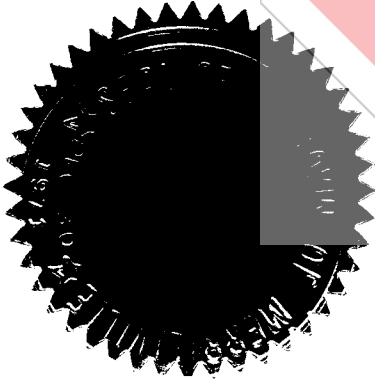
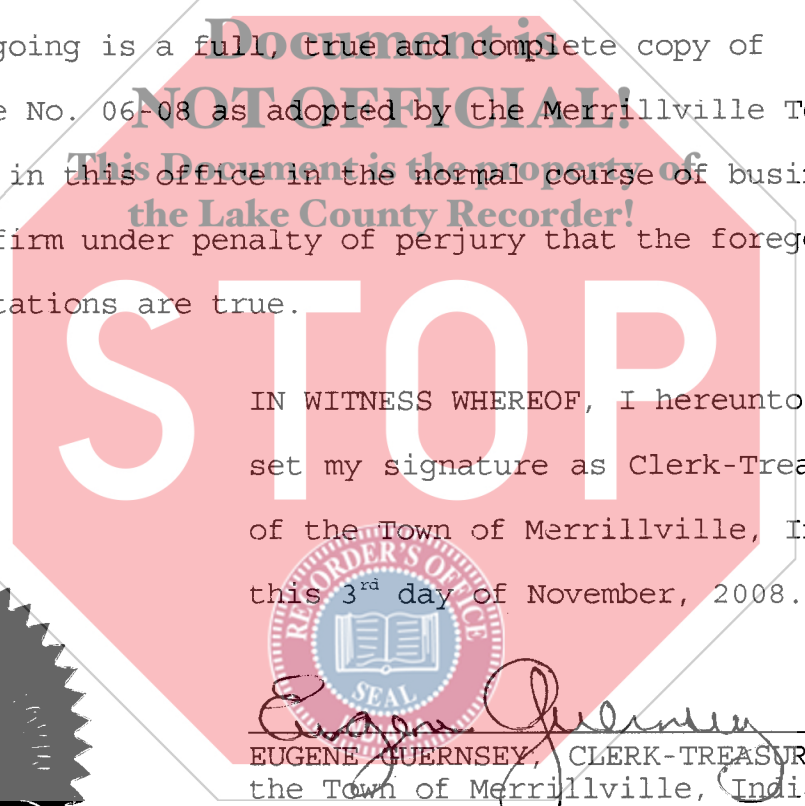

ORDINANCE NO. 06-08
TOWN OF MERRILLVILLE, INDIANA
AN ORDINANCE OF THE TOWN OF MERRILLVILLE, LAKE COUNTY, INDIANA,
VACATING A LOT, STREET AND/OR ALLEY IN THE TOWN OF MERRILLVILLE

WHEREAS, Robert Wolfberg, Petitioner as Prospective Owner c/o Attorney Geoffrey G. Giorgi have a petition to vacate a lot, street and/or alley in the Town of Merrillville, Indiana; and

WHEREAS, a Public Hearing has been held as required by Indiana Code 36-7-3-12; and

WHEREAS, the Town Council of the Town of Merrillville has determined after said Public Hearing that the subject property shall be vacated;

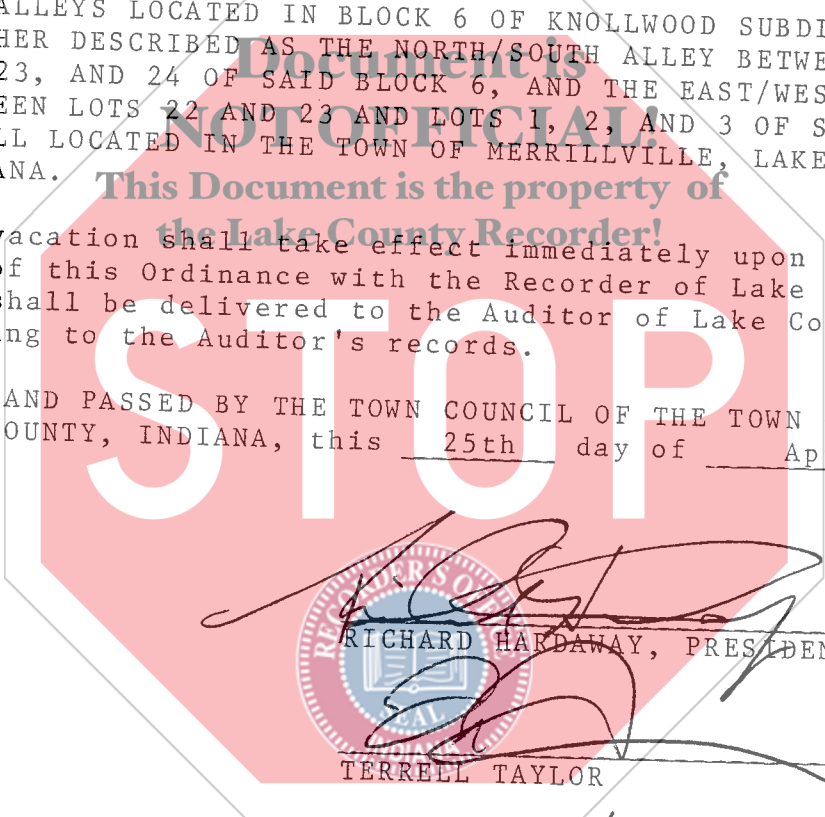
NOW, THEREFORE, BE IT ORDAINED by the Town of Merrillville, to wit:

- 1. That the following described lot, street and/or alley be vacated by the Town of Merrillville, to wit:

THE ALLEYS LOCATED IN BLOCK 6 OF KNOLLWOOD SUBDIVISION, FURTHER DESCRIBED AS THE NORTH/SOUTH ALLEY BETWEEN LOTS 22, 23, AND 24 OF SAID BLOCK 6, AND THE EAST/WEST ALLEY BETWEEN LOTS 22 AND 23 AND LOTS 1, 2, AND 3 OF SAID BLOCK 6, ALL LOCATED IN THE TOWN OF MERRILLVILLE, LAKE COUNTY, INDIANA.

- 2. The vacation shall take effect immediately upon the recording of this Ordinance with the Recorder of Lake County and shall be delivered to the Auditor of Lake County for posting to the Auditor's records.
