This Power of Attorney is not affected by my subsequent disability or incapacity.

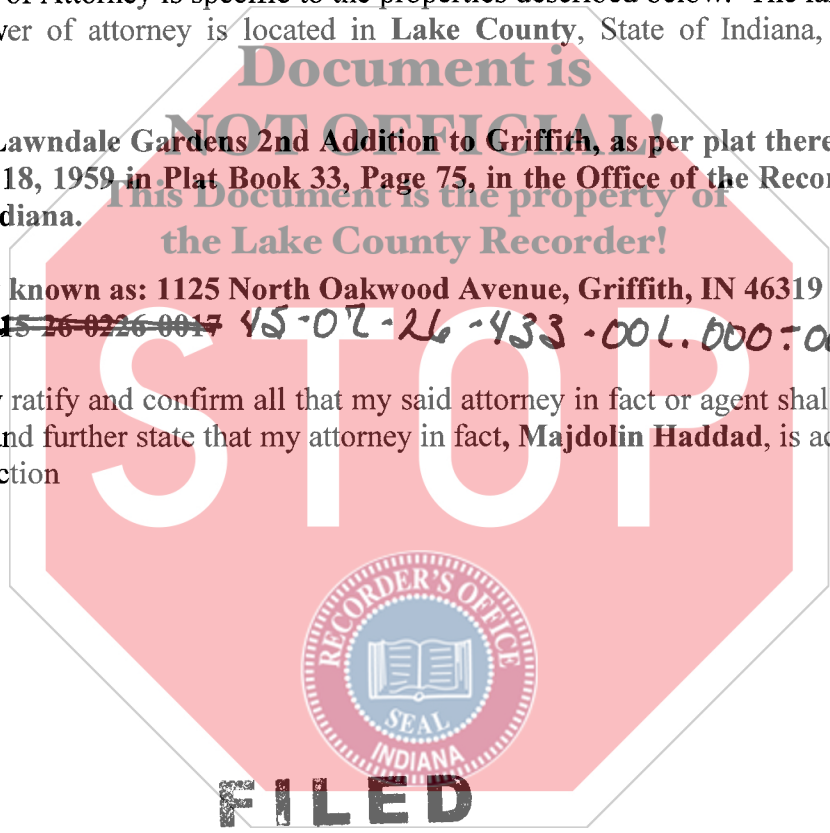
