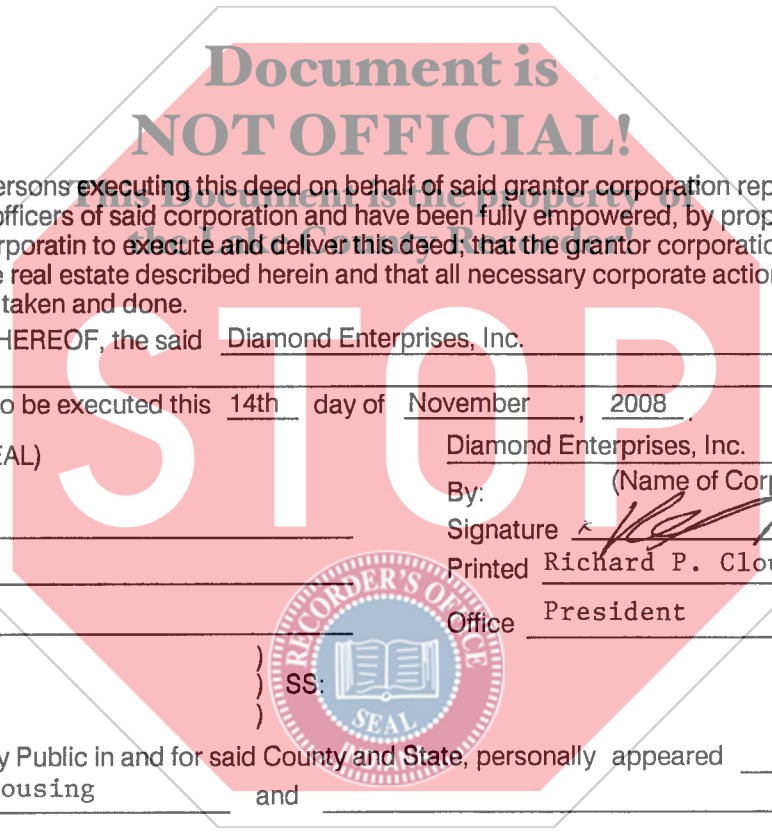
THIS INDENTURE WITNESSETH, That Diamond Enterprises, Inc.
