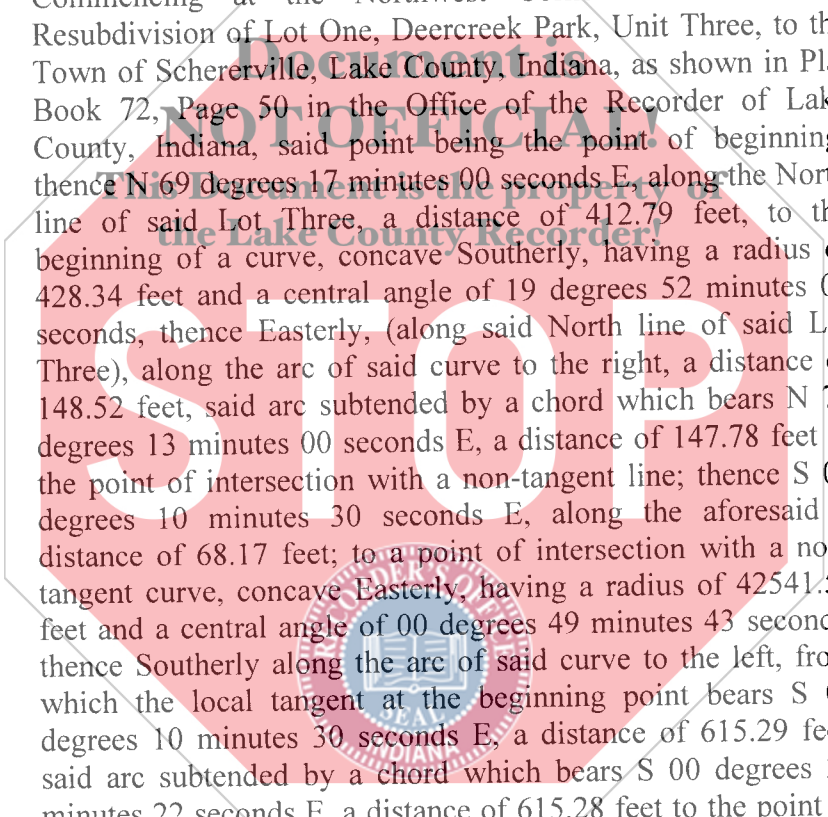

DISCLAIMER OF INTEREST IN REAL PROPERTY

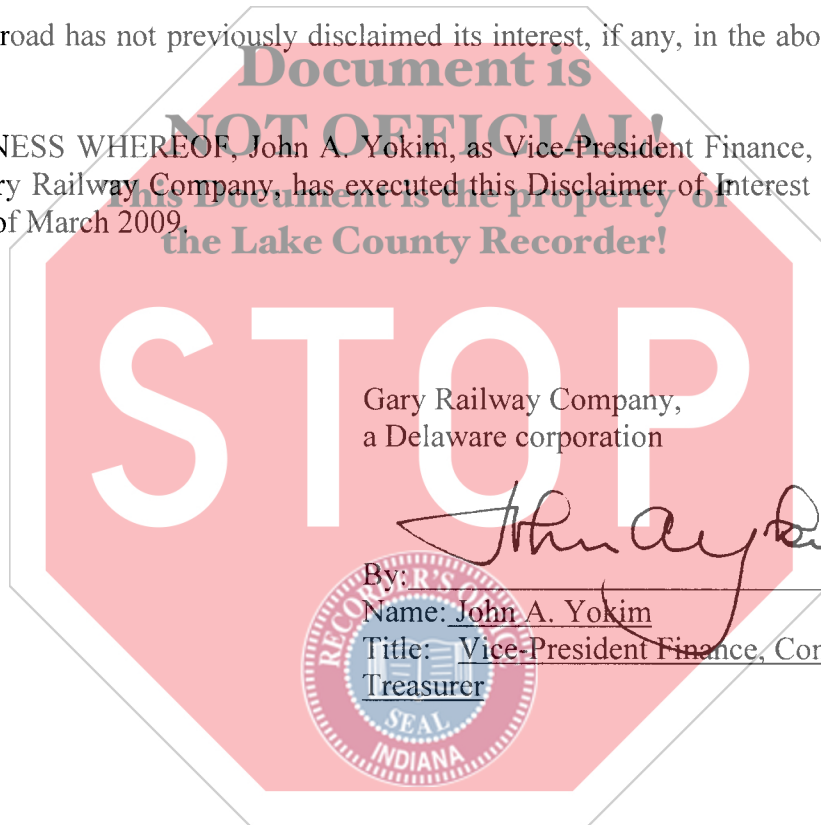

intersection with a non-tangent line; thence N 88 degrees 59 minutes 47 seconds E, along the Northerly line of said Lot Three, a distance of 90.00 feet; to a point of intersection with a non-tangent curve, concave Easterly, being the Westerly Right-of-Way line of U.S. Highway 41, having a radius of 42451.59 feet and central angle of 00 degrees 14 minutes 14 seconds, thence Northerly along the arc of said curve to the right; from which the local tangent at the beginning point bears N 01 degrees 00 minutes 13 seconds W, a distance of 175.79 feet, said arc subtended by a chord which bears N 00 degrees 53 minutes 06 seconds W, a distance of 175.79 feet to the point of intersection with a non-tangent line; thence S 89 degrees 14 minutes 01 second W, along said U.S. Highway 41 Right-of-Way Line, a distance of 40.00 feet; to a point of intersection with a non-tangent curve, concave Easterly, having a radius of 42491.59 feet and a central angle of 00 degrees 35 minutes 29 seconds, thence Northerly (along the aforesaid Right-of-Way Line) along the arc of said curve to the right, from which the local tangent at the beginning point bears N 00 degrees 45 minutes 59 seconds W, a distance of 438.61 feet, said arc subtended by a chord which bears N 00 degrees 28 minutes 15 seconds W, a distance of 438.61 feet to the point of intersection with a non-tangent line; thence N 00 degrees 27 minutes 38 seconds W, continuing along said Right-of-Way Line, a distance of 118.17 feet; thence S 89 degrees 49 minutes 30 seconds W, a distance of 50.00 feet; to a point of intersection with a non-tangent curve, concave Southerly, having a radius of 478.34 feet and a central angle of 19 degrees 52 minutes 00 seconds, thence Westerly along the arc of said curve to the left, from which the local tangent at the beginning point bears S 89 degrees 09 minutes 00 seconds W, a distance of 165.86 feet, said arc subtended by a chord which bears S 79 degrees 13 minutes 00 seconds W, a distance of 165.03 feet to the curve's end which intersects the Southerly Right-of-Way Line of the Elgin, Joliet and Eastern Railroad; thence S 69 degrees 17 minutes 00 seconds W, continuing along said Right-of-Way

Line, a distance of 412.79 feet; thence S 20 degrees 43 minutes 00 seconds E, along the Easterly Right-of-Way Line of Eagleridge Drive, a distance of 50.00 feet, to the point of beginning; containing 1.66 acres, more or less.

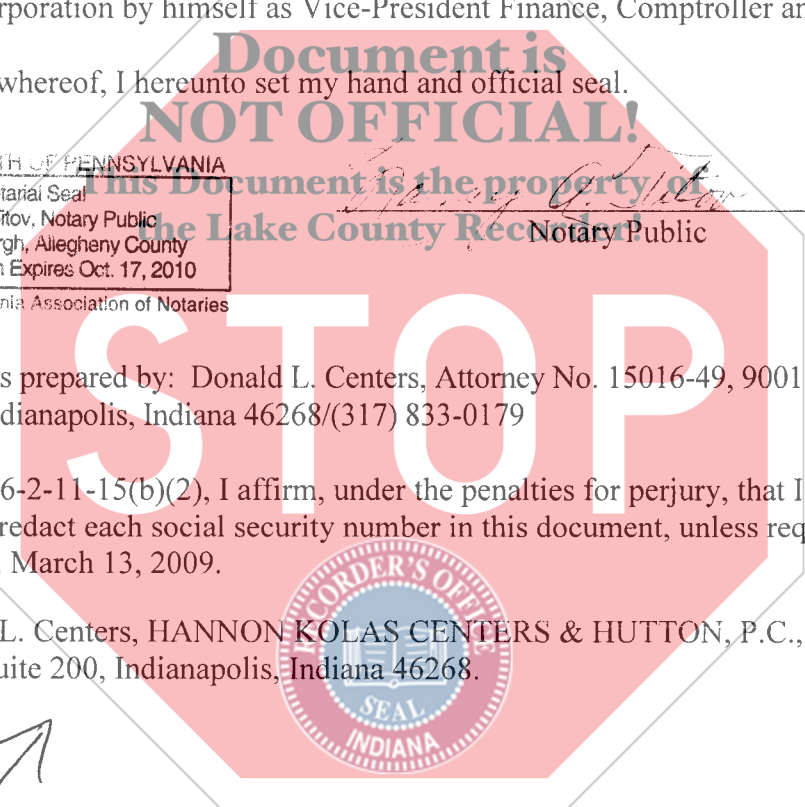
