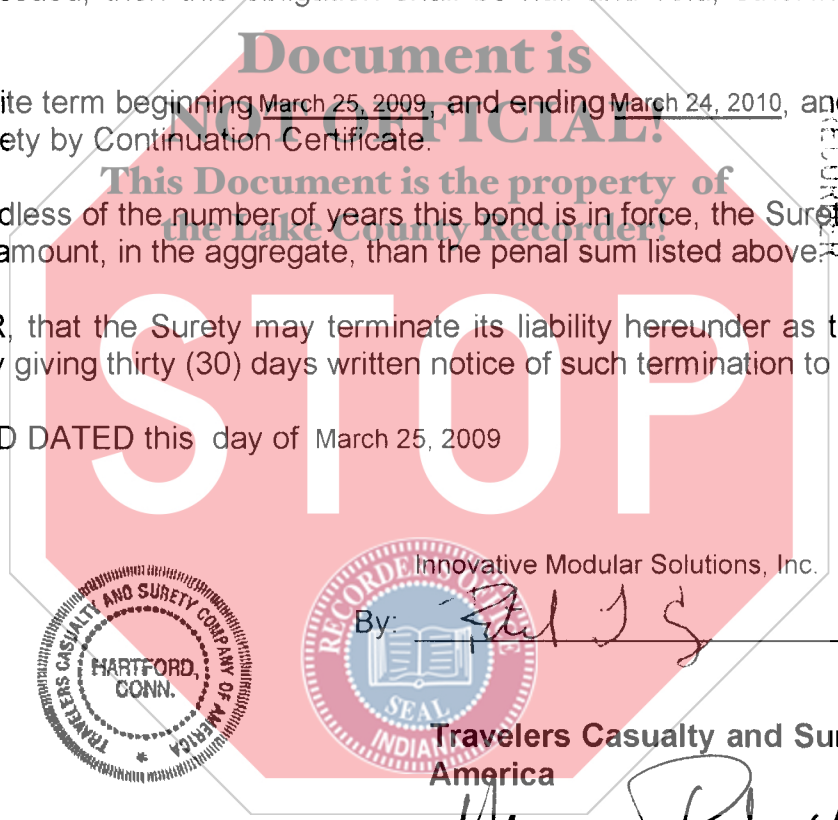
NOW, THEREFORE, THE CONDITIONS OF THIS OBLIGATION ARE SUCH, that if the Principal

Principal at any time by giving thirty (30) days written notice of such termination to the Obligee.

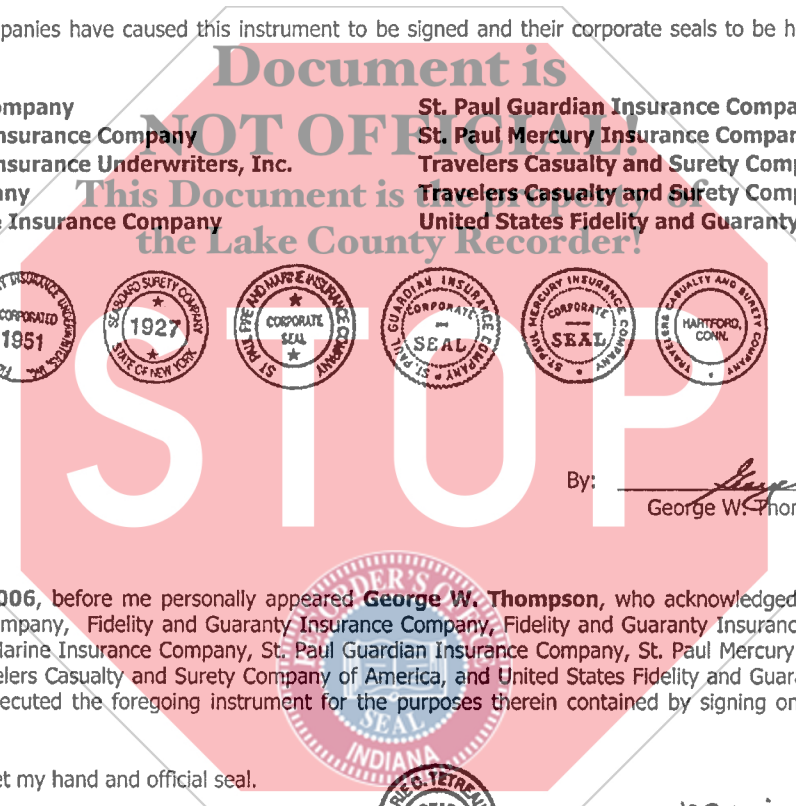
