authorized by Section 401 of the Water Resources Development Act of 1986 (P. 99-662) to construct, maintain, repair, operate, patrol and replace a flood protection levee, including all appurtenances thereto; reserving, however, to the owners, their heirs and assigns, all such rights and privileges in the land as may be used without interfering with or abridging the rights and easement hereby acquired; subject however to existing easement for public roads and highways, public utilities, railroads and pipelines as long as they do not interfere with the project.




thence North 00°03'18" East along the west line of Calumet Avenue a distance of 117.69 feet:

thence North 00°03'18" East along said line a distance of 25.45 feet to the Point of Beginning, said parcel containing 0.247 acres, more or less.
