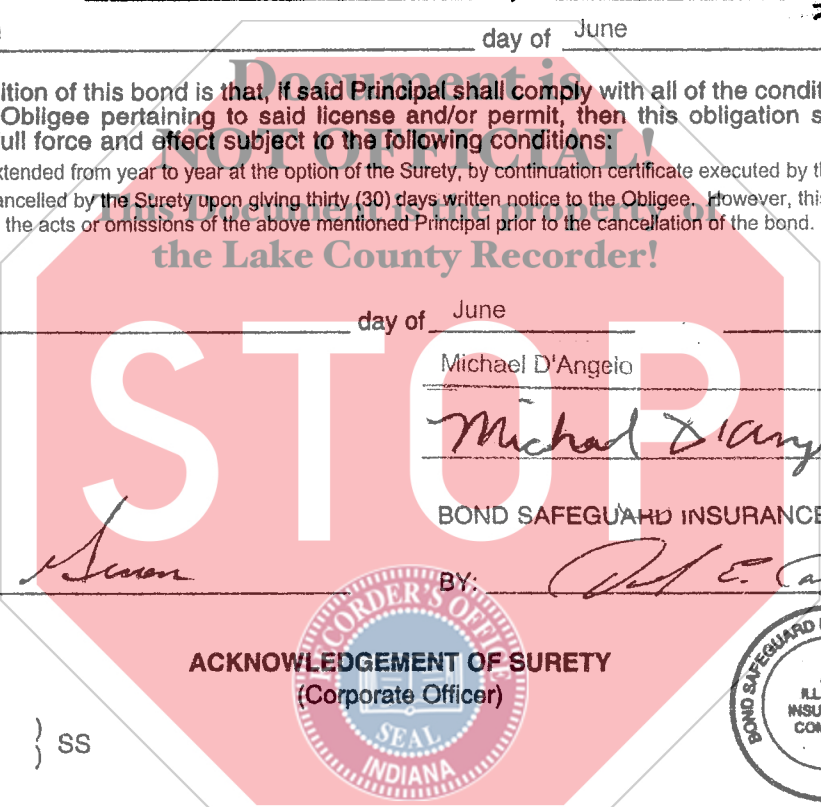
In consideration thereof, the Principal is granted a license and/or permit by the Obligee to engage in the business of Construction/Carpentry

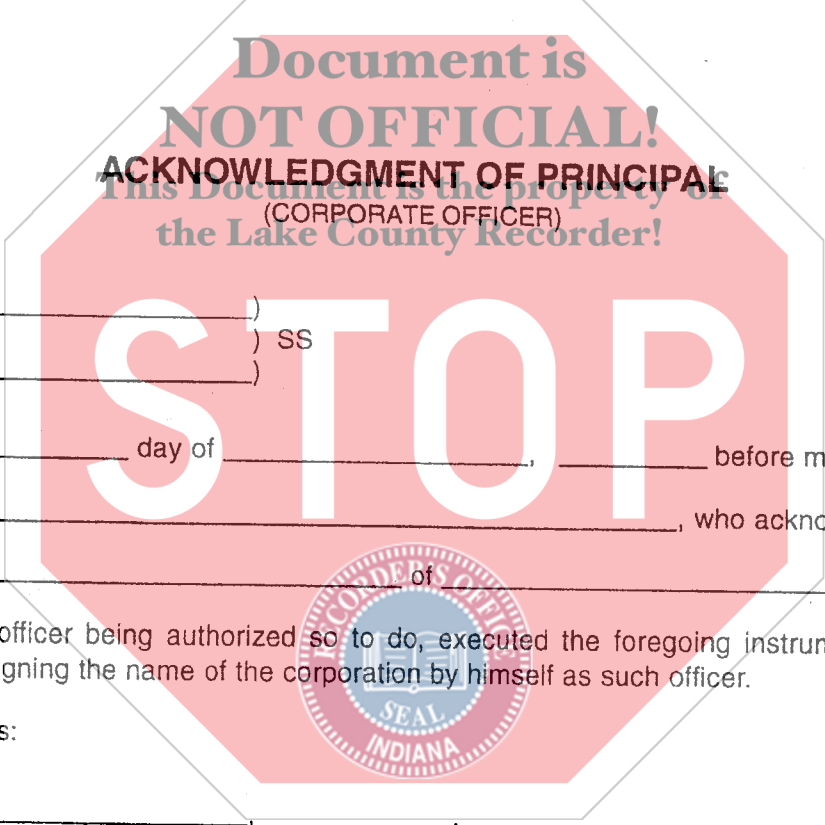
