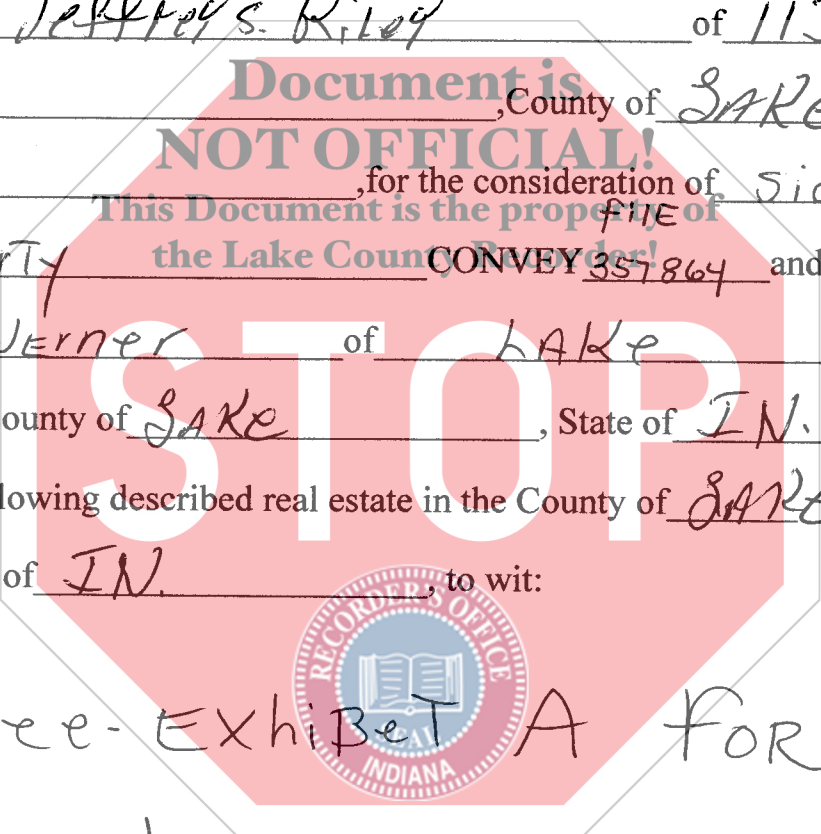

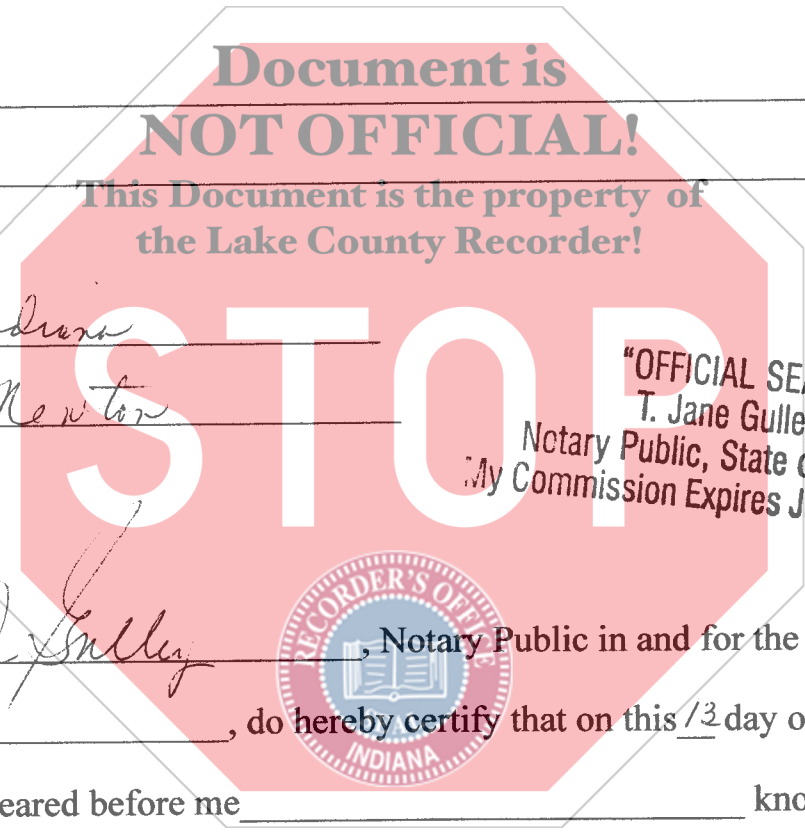

Part of the Southeast Quarter of Section 5, Township 32 North, Range 9 West of the Second Principal Meridian, in Lake County, Indiana, more particularly described as follows: Commencing at the Southeast corner of the above said Section 5; thence North along the East line of said Section 5, a distance of 2049.10 feet to the intersection of center line of State Road #2 with the above said East Section line; thence Southwesterly along said center line of State Road #2, a distance of 465.20 feet to the place of beginning of this description; thence Northwesterly at an angle of 100 degrees, 35 minutes West to North from the last mentioned course, a distance of 206.60 feet; thence Southwesterly parallel with the center line of said State Road 128 feet; thence Southeasterly 206.60 feet to a point in said center line of State Road #2 which is 128 feet distance from the place of beginning; thence Northeasterly 128 feet to the place of beginning, in Lake County, Indiana.
