the Court and a part of this Court's record.

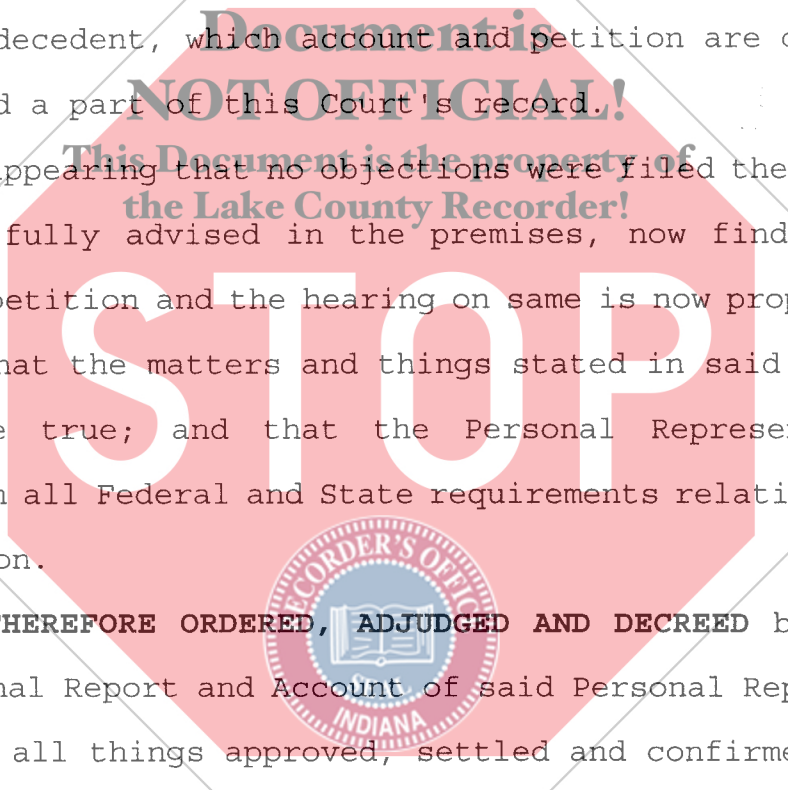
And it appearing that no objections were filed thereto and the

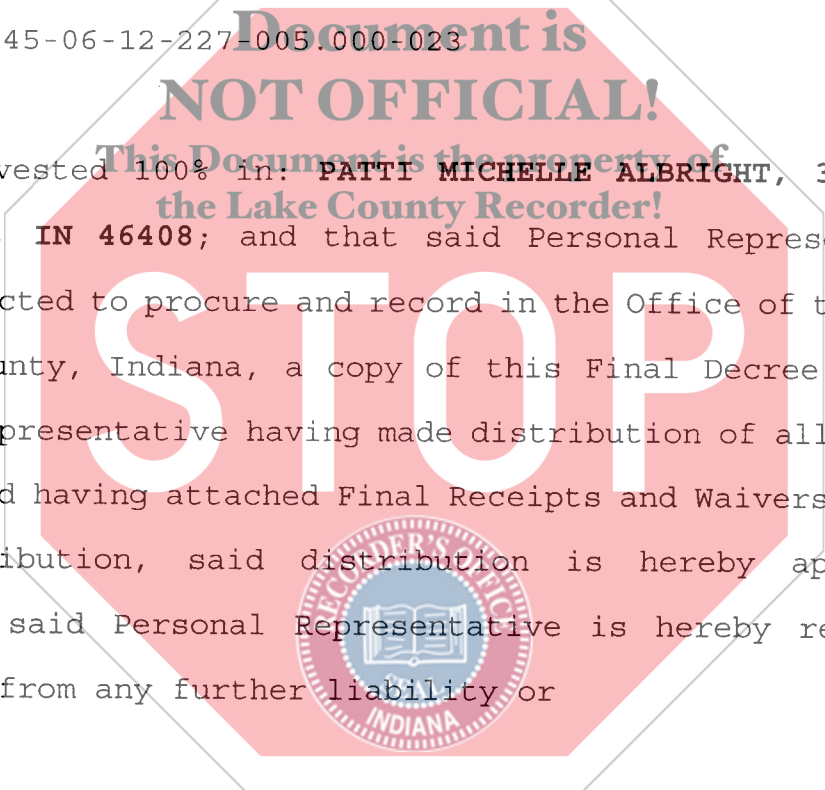



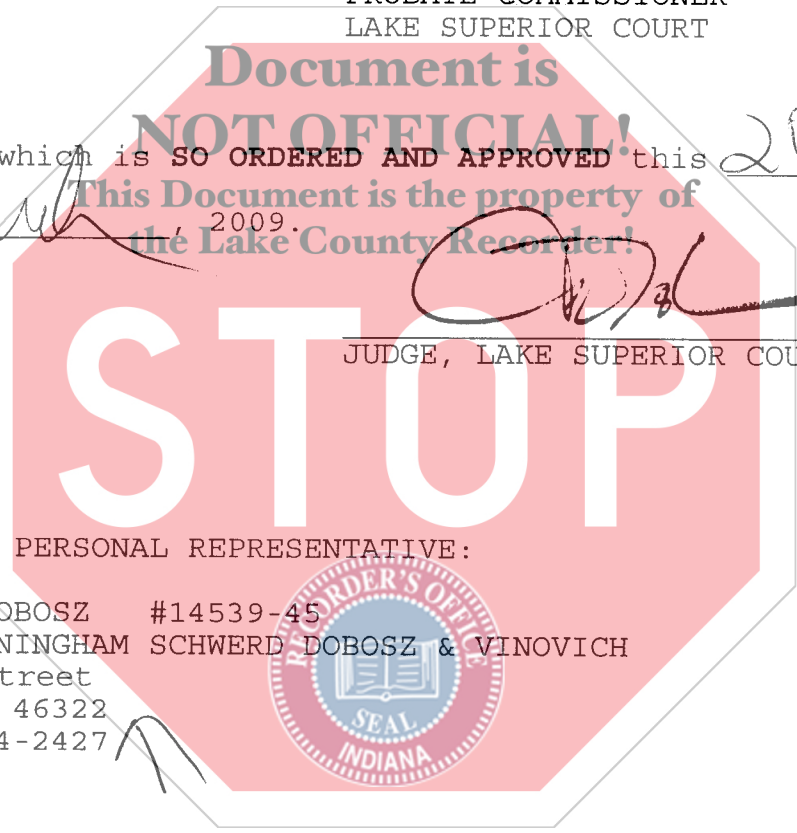
