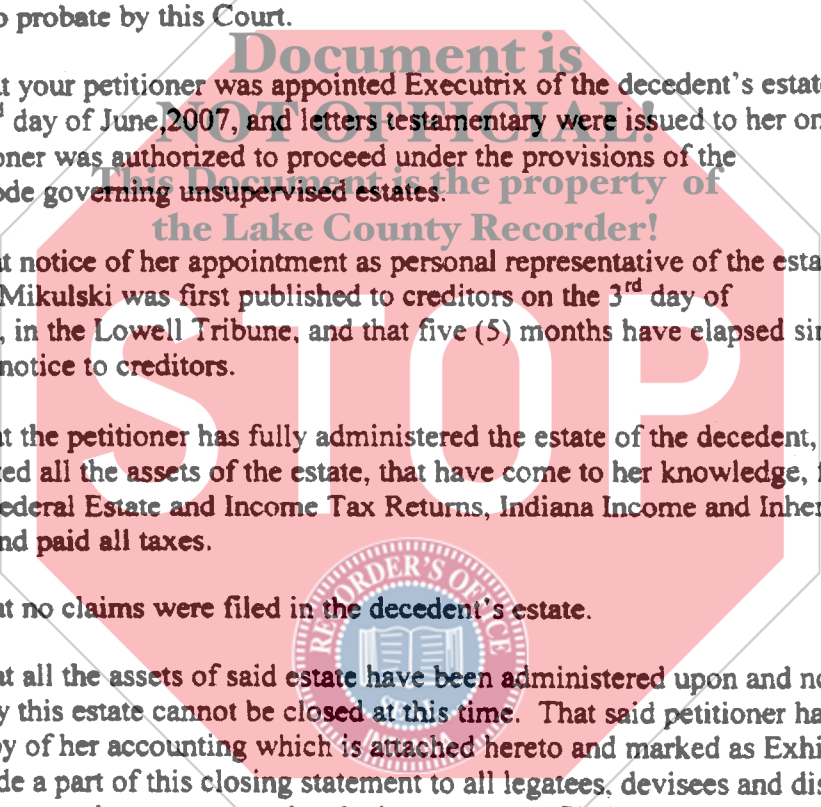

EXECUTOR'S VERIFIED CLOSING STATEMENT  
TO CLOSE ESTATE UPON COMPLETION OF ADMINISTRATION

Comes now Bridget A. Struhs, as Executrix of the estate of Joseph R. Mikulski deceased, who having been duly sworn upon her oath alleges as follows:

1. That on 6<sup>th</sup> day of May, 2007, the decedent herein died testate, domiciled in Lake County, Indiana, Thereafter, on the 22<sup>nd</sup> day of June 2007, his Last Will and Testament dated the 28<sup>th</sup> day of January 2005, was duly admitted to probate by this Court.
2. That your petitioner was appointed Executrix of the decedent's estate on the 22<sup>nd</sup> day of June, 2007, and letters testamentary were issued to her on that date and said petitioner was authorized to proceed under the provisions of the Indiana Code governing unsupervised estates.
3. That notice of her appointment as personal representative of the estate of Joseph R. Mikulski was first published to creditors on the 3<sup>rd</sup> day of July, 2007, in the Lowell Tribune, and that five (5) months have elapsed since the first published notice to creditors.
3. That the petitioner has fully administered the estate of the decedent, in that she has collected all the assets of the estate, that have come to her knowledge, filed all required Federal Estate and Income Tax Returns, Indiana Income and Inheritance Tax Returns, and paid all taxes.
5. That no claims were filed in the decedent's estate.
6. That all the assets of said estate have been administered upon and no reason exists why this estate cannot be closed at this time. That said petitioner has forwarded a copy of her accounting which is attached hereto and marked as Exhibit "A", and made a part of this closing statement to all legatees, devisees and distributees and her respective consent to the closing statement filed by the petitioner herein acquiescing to the facts set forth is attached thereto as Exhibit "B".


