

KNOW ALL MEN BY THESE PRESENTS, that Deutsche Bank National Trust Company, a national banking association organized and existing under the laws of the United States, formerly known as Bankers Trust Company of California, N.A., and having its principal place of business at 1761 East St. Andrew Place, Santa Ana, California, 92705, as Trustee (the "Trustee") pursuant to the Pooling and Servicing Agreements (the "Agreements") listed on the attached Exhibit hereby constitutes and appoints Citi Residential Lending Inc. continue in full force and effect and has not been revoked unless an instrument of revocation has been made in writing by the undersigned.
