### Assignment of Mortgage

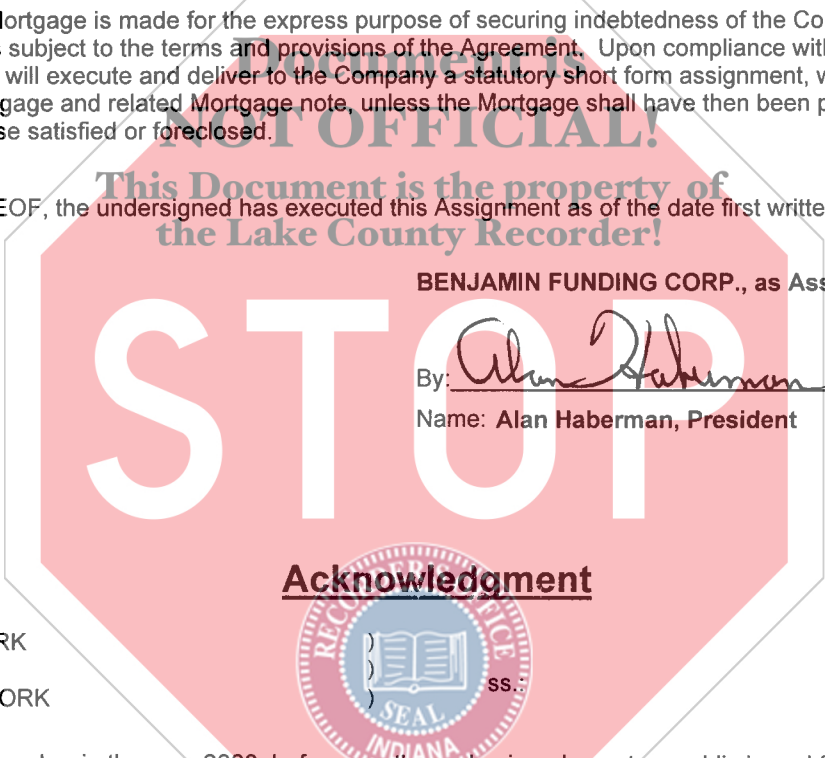

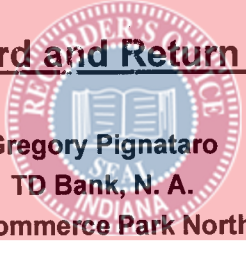


