Further Provided, However, that this bond may be continued from year to year by certificate executed by the Surety hereon.

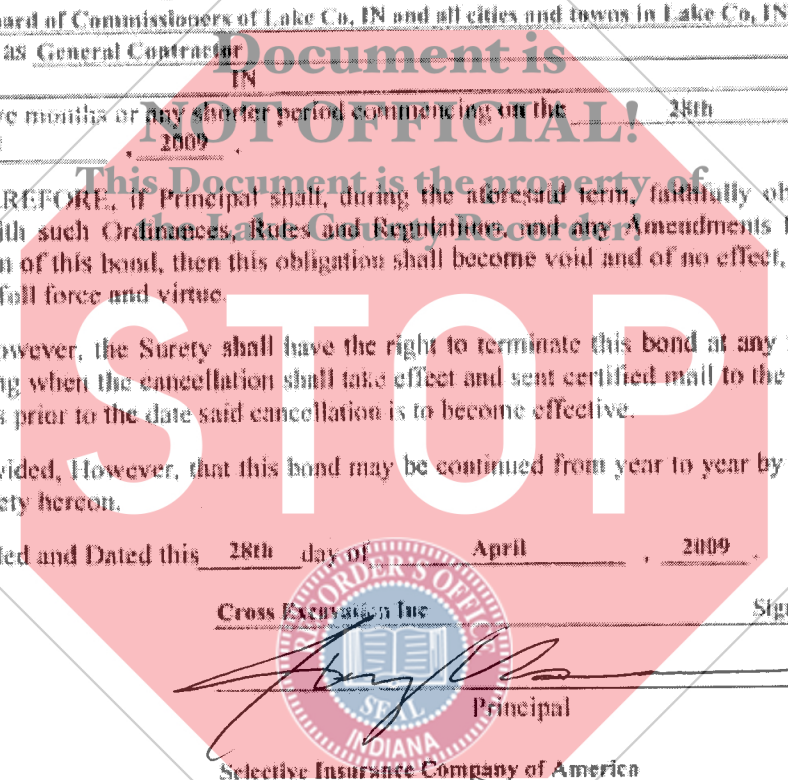

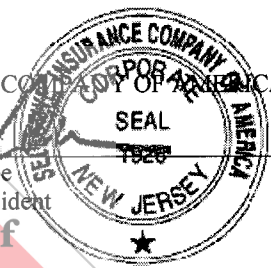

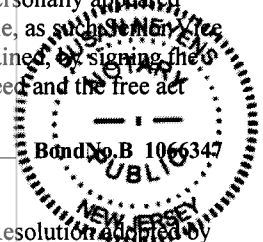
