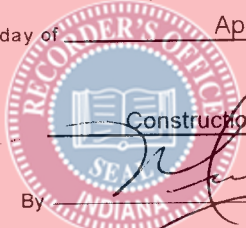
WHEREAS, the said Principal has applied to said Oblige for a license to or permit as a Carpentry Contractor
