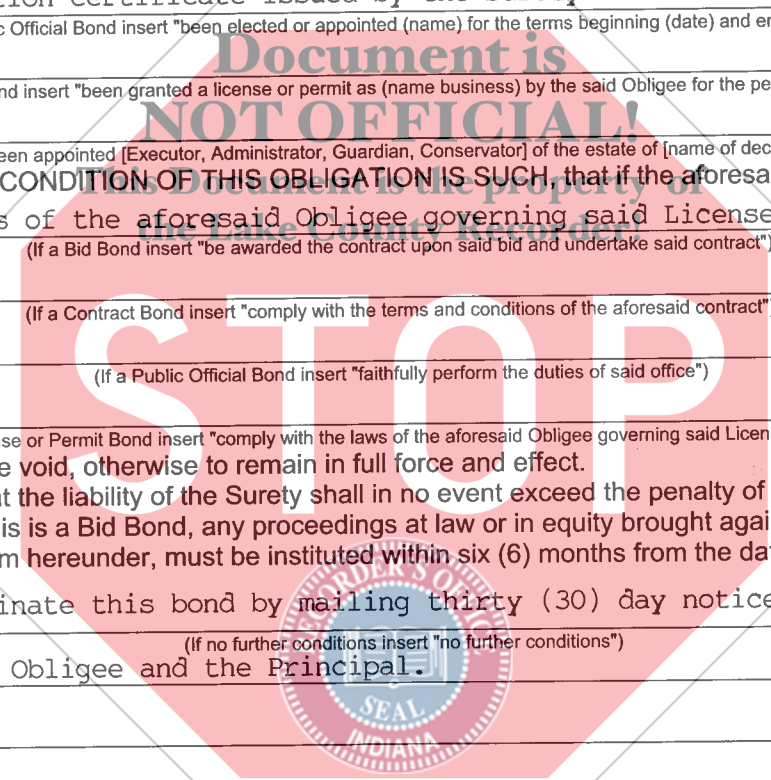
PROVIDED: FIRST: - That the liability of the Surety shall in no event exceed the penalty of this Bond.

## POWER OF ATTORNEY

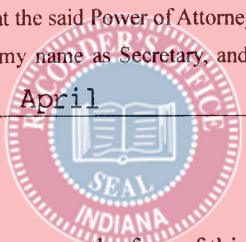
