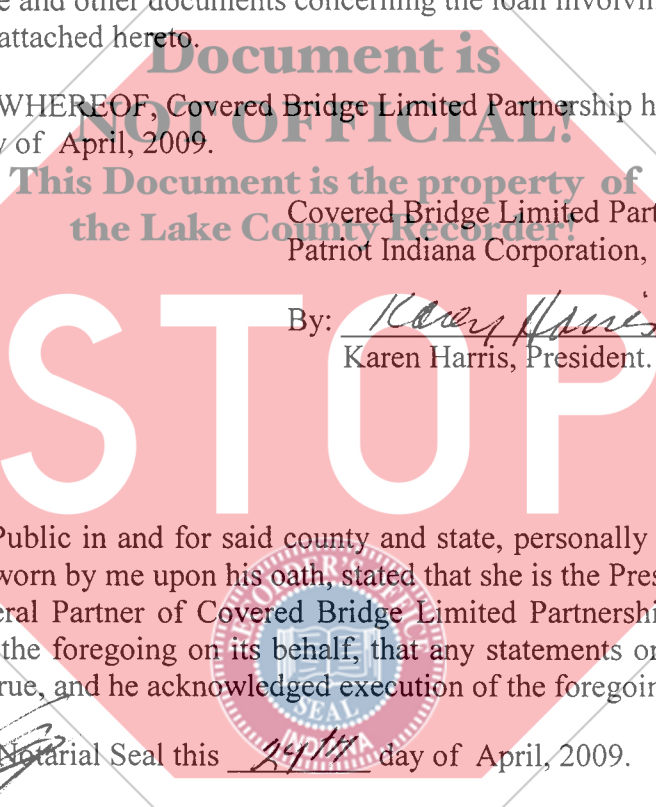

**EXHIBIT A
LEGAL DESCRIPTION**

Parcel I:

That part of the Northeast Quarter of the Northeast Quarter of Section 8, Township 36 North, Range 9 West, of the Second Principal Meridian in Lake County, Indiana, more particularly described as follows:

Beginning at a point in the East and West centerline of the Northeast Quarter of the said Section 8, said point being 328.24 feet West of the East line of the said Northeast Quarter of said Section 8, measured along said centerline; thence North 0 degrees 02 minutes 30 seconds East, a distance of 539.49 feet more or less, to the Southerly 100 foot right of way line of the New York Central Railroad Company; thence North 56 degrees 22 minutes West, along the Southerly right of way line, a distance of 593.82 feet; thence South 0 degrees 02 minutes 30 seconds West a distance of 868.96 feet, more or less, to the said centerline of the said Northeast Quarter of the said Section 8; thence North 89 degrees 56 minutes East, along said centerline a distance of 494.66 feet to the point of beginning, all in the City of Hammond, Lake County, Indiana containing 8.84 acres, more or less.

Parcel II:

A part of the Northeast Quarter of the Northeast Quarter of Section 8, Township 36 North, Range 9 West of the Second Principal Meridian in the City of Hammond, Lake County, Indiana, the boundaries of which are more particularly described as follows, to-wit:

Beginning at a point in the East and West center line of the Northeast Quarter of the said Section 8, said point being 822.90 feet West of the East line of the said Northeast Quarter of the said Section 8, measured along said center line, thence North 0 degrees 02 minutes 30 seconds East a distance of 868.96 feet, more or less, to the Southerly 100 feet right of way line of the New York Central Railroad Company as deeded to said Railroad in Deed Record 926, page 270, recorded November 3, 1952; thence North 56 degrees 22 minutes West along said Southerly right of way line a distance of 594.79 feet, more or less to a point on the North and South center line of said Northeast Quarter of the said Section 8; thence Southerly along the said North and South center line of said Northeast Quarter of the said Section 8 a distance of 1198.98 feet, more or less, to its intersection with the East and West centerline of the said Northeast Quarter of said Section 8; thence East along said East and West centerline a distance of 491.92 feet, more or less, to the place of beginning containing 10.618 acres, more or less.
