KNOW ALL MEN BY THESE PRESENTS, THAT for and in consideration of the sum of Ten Thousand and No Cents Dollars (\$10,000) in hand paid, the receipt of which is hereby acknowledged, the undersigned does hereby grant unto TE Products Pipeline Company, LLC, ("TEPPCO") a Texas limited liability company, the Grantee, its successors and assigns, the right to construct, install, maintain, inspect, operate, repair, replace, change or remove valves (including but without limitation, gate, block and check valves), drips and appurtenances, together with the right to enclose the valve with a Forty foot (40') by Eighty foot (80') guard rail or fence on the following-described land in the County of Lake, State of Indiana to-wit:

That part of Government Lot 1, as established by the Government Survey of 1834, lying Westerly and Northerly of the centerline of the Levee Ditch (running Northeasterly and Southwesterly), in the Northeast Quarter of Section 1, Township 31 North Range West of the 2nd P.M., except the East 128 feet thereof, in Lake County, Indiana. Key No. 3-2-20.

Grantee, its successors and assigns, shall at all times have full rights of ingress and egress to and from said land for the full enjoyment by Grantee of the rights granted herein.

TO HAVE AND TO HOLD the said rights and easement to Grantee, its successors and assigns, so long as said structures or any thereof, are maintained.

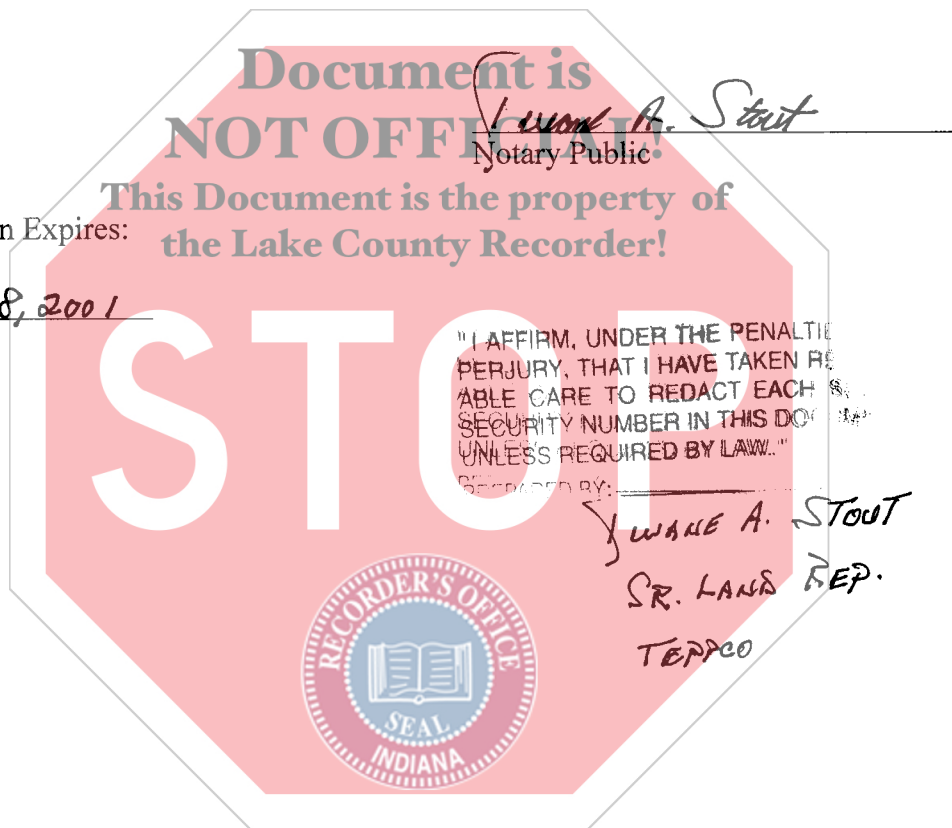
