ASSIGNMENT OF MORTGAGE

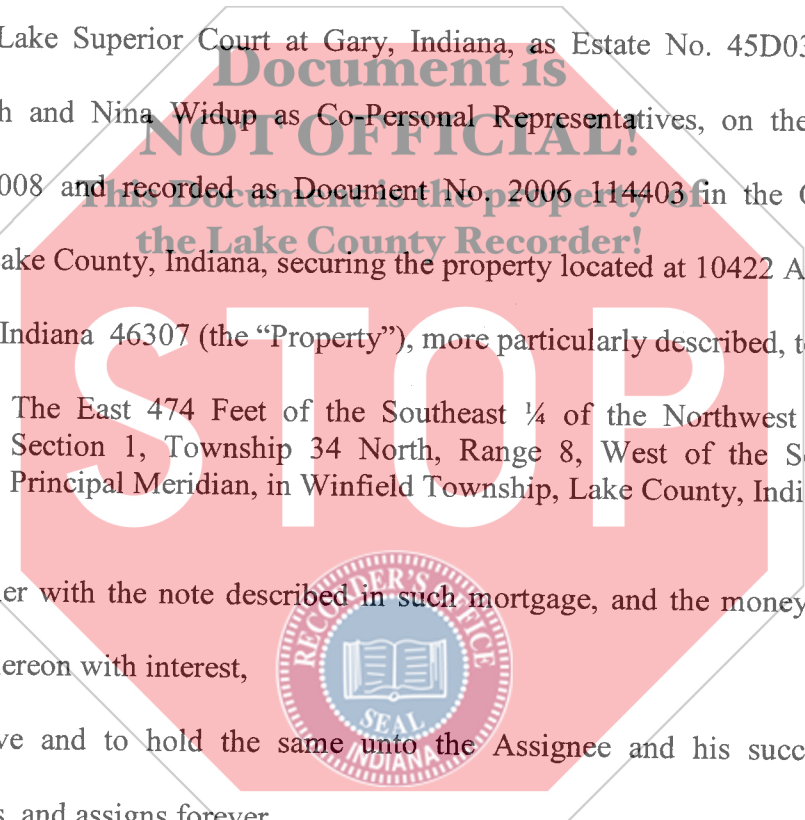

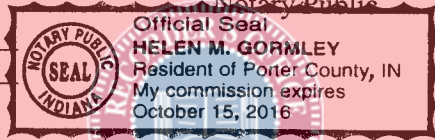
