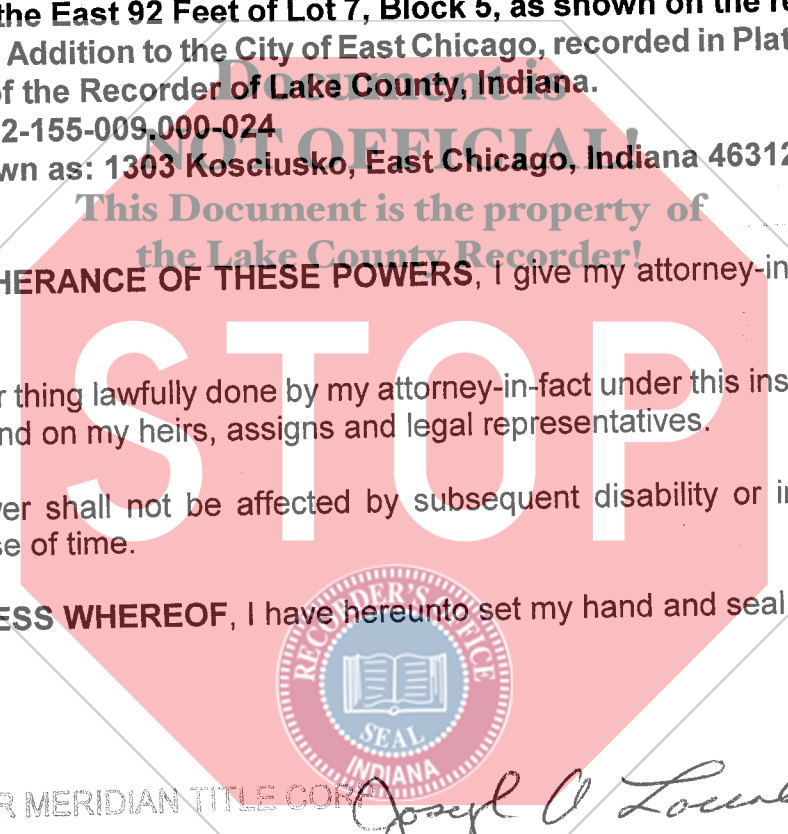
# LIMITED POWER OF ATTORNEY



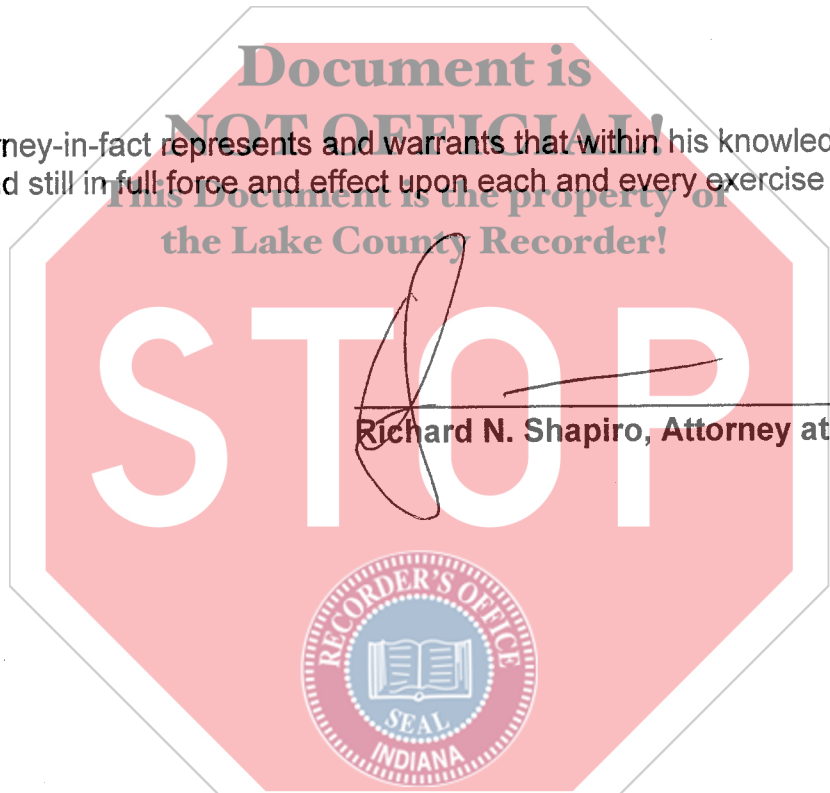
