The undersigned being first duly sworn alleges or deposes as follows:


1. That he/she is employed by the undersigned and is authorized by the note holder to make this affidavit.

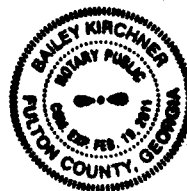
