COLLATERAL ASSIGNMENT OF MORTGAGE

THIS COLLATERAL ASSIGNMENT OF MORTGAGE (this "Assignment") is made as of April 2, 2009, by STABFUND SUB NCA AG, a Swiss corporation (Aktiengesellschaft) ("Assignor"), having an address at c/o Schweizerische Nationalbank, Bundesplatz 1, 3011 Berne, Switzerland, to and in for the benefit of SWISS NATIONAL BANK, a corporation (Aktiengesellschaft) formed under the Swiss National Bank Act ("Assignee"), having an address at Borsentrasse 15, 8022 Zurich, Switzerland.

WHEREAS, Assignor has pledged all of its right, title and interest in and to the Mortgage (as hereinafter defined) to Assignee pursuant to that certain Amended and Restated Security Agreement (as amended, supplemented or otherwise modified from time to time, the "Security Agreement") dated as of March 12, 2009, by and among Assignor, Assignee, SNB StabFund Kommanditgesellschaft Für Kollektive Kapitalanlagen, a Swiss limited partnership for collective investment, StabFund Sub CA AG, a Swiss corporation (Aktiengesellschaft), and StabFund (USA) INC., a Delaware corporation.

NOW, THEREFORE, for good and sufficient consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby collaterally assigns, transfers, and delivers to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to that certain Mortgage, Assignment of Leases and Rents, Fixture Filing and Security Agreement, dated as of January 31, 2008, made by MERRILLVILLE ACQUISITION LLC, a Delaware limited liability company, to UBS Real Estate Securities Inc., a Delaware corporation ("UBS"), recorded among the land records of Lake County, Indiana, on February 8, 2008, as Instrument Number 2008009344, as assigned by that certain Assignment of Mortgage dated as of April 2, 2009, made by UBS to Assignor, recorded on or about such date among the land records of Lake County, Indiana (as so assigned, the "Mortgage"), which Mortgage encumbers certain real property more particularly described on Exhibit A, attached hereto and made a part hereo
