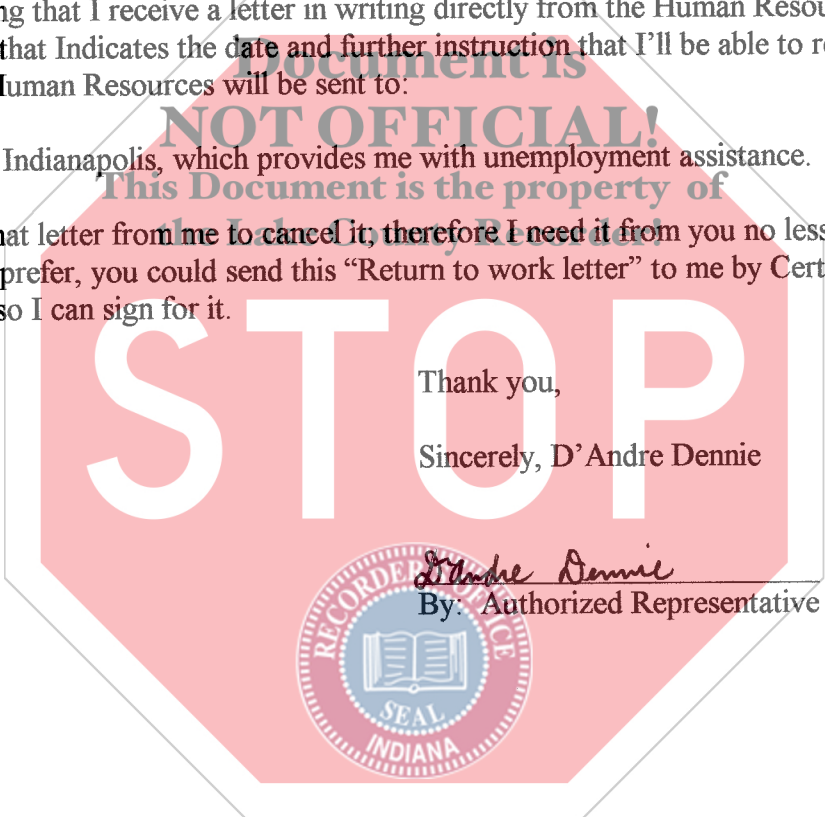
Greetings!

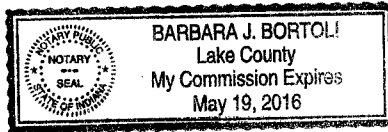
