due and payable thereafter.

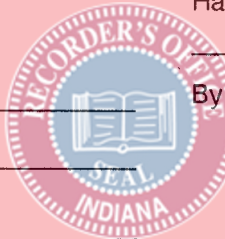

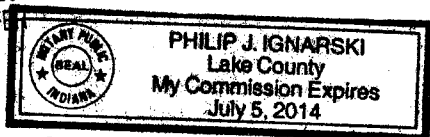
