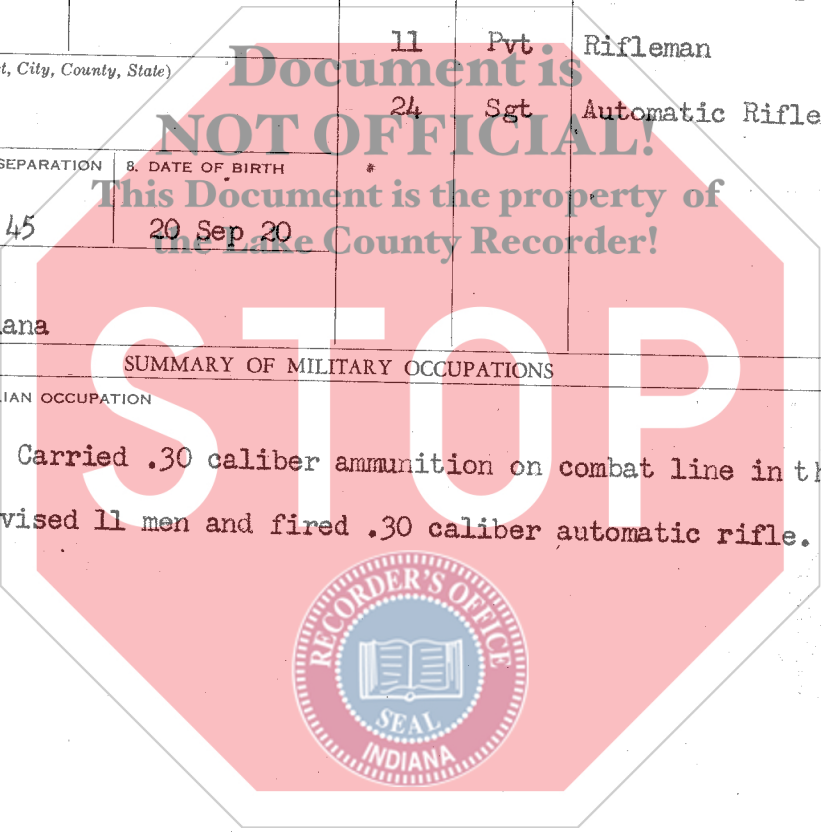
SEPARATION QUALIFICATION RECORD
