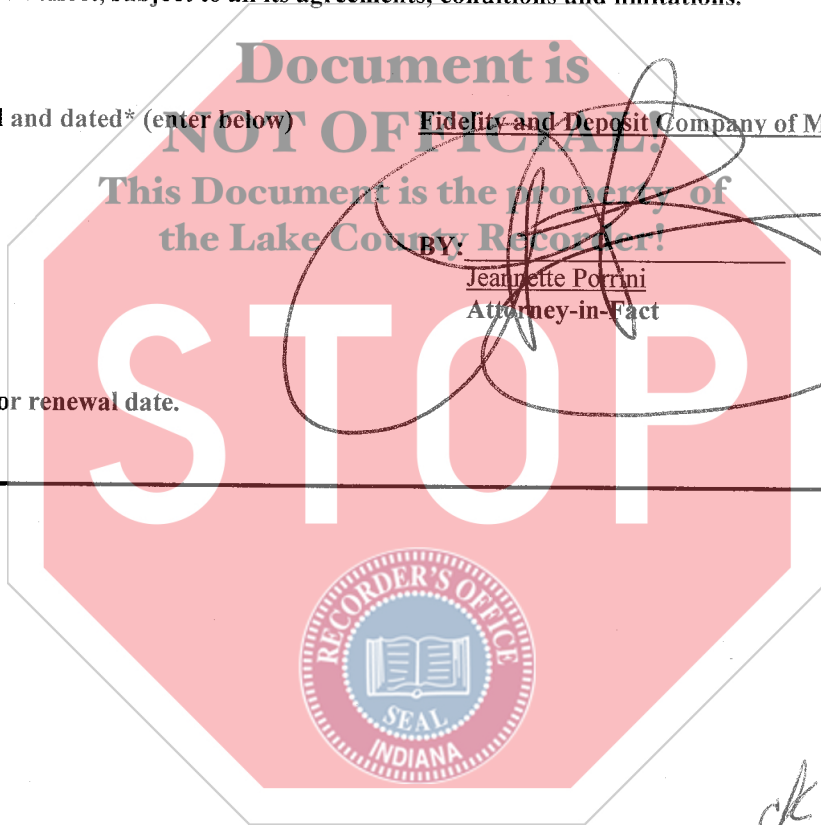

“Article VI, Section 2.
