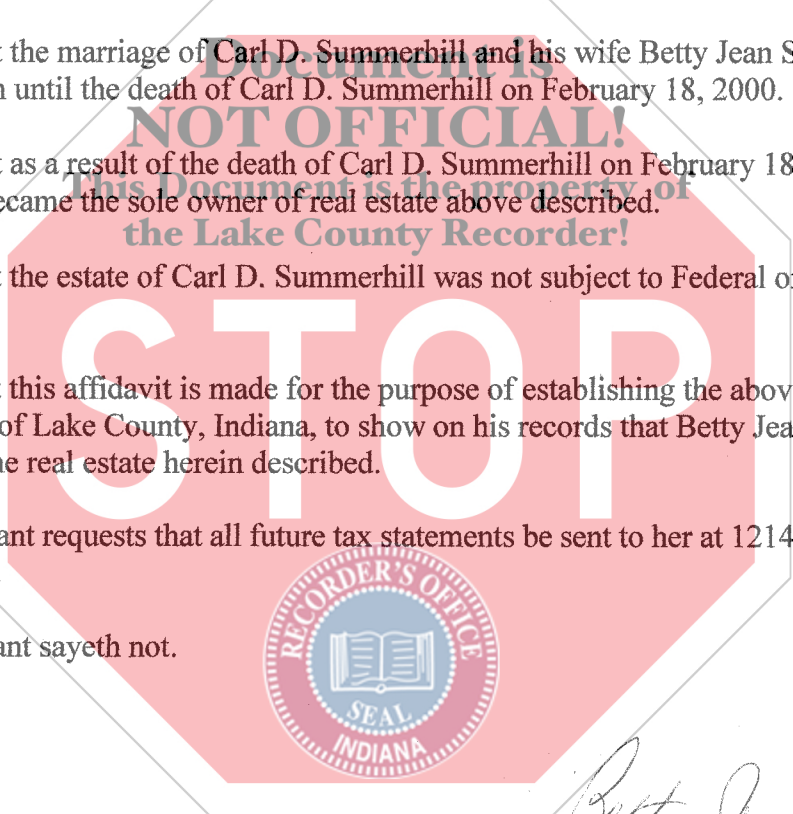
4. That as a result of the death of Carl D. Summerhill on February 18, 2000, Betty Jean Summerhill became the sole owner of real estate above described.

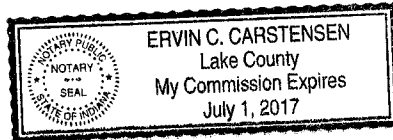

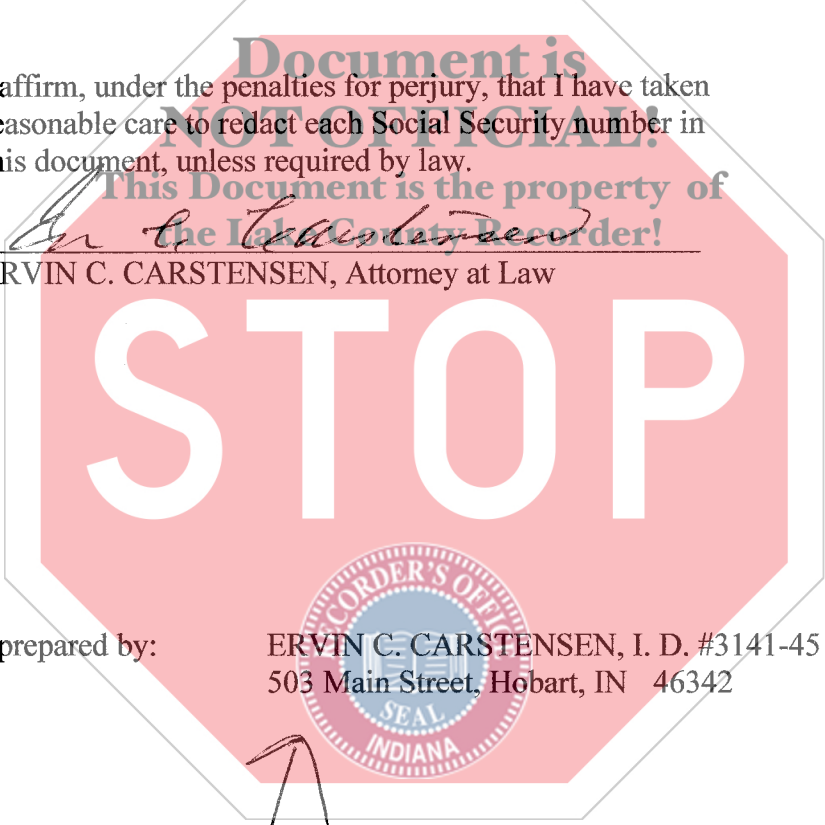
