



Act; and that all estate taxes, inheritance taxes, and gross income taxes, if any, assessed in this Estate have been paid.

5. That the following person is the sole legatee and devisee under the decedent's Last Will and Testament: Florence M. Link; that the assets and property of this Estate as shown on the Final Accounting to which the above person is entitled under the Will of the decedent are ready for distribution.

6. That all of the net assets and property of the estate should now be transferred by the Personal Representative into the name of the sole beneficiary, consistent with the last Will and Testament of the decedent, namely, Florence Miller Link, including, but not limited to, the real estate commonly known as 4429 Hickory, Hammond, Indiana, as more particularly described below; the 2005 Cadillac automobile bearing VIN: 1G6KD54Y75U221253; the Chase Bank Checking Account No. 180000166405; all stocks, bonds, individual retirement accounts, retirement accounts, monies and the balance of all funds contained in that certain account in the name of the estate and Personal Representative held by Financial Network with offices located in Highland, Indiana; and any and all other assets owned by the decedent and the net assets of the estate.

IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED, by the Court, as follows:

1. That the Final Report, Petition to Settle and Allow Account, and Petition for Authority to Distribute Assets Remaining and Close Estate of the Personal Representative is hereby in all things approved, settled, and confirmed.

2. That distribution of the balance of the property remaining in the Personal Representative's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of the decedent and is hereby in all things approved.

3. That the real estate commonly known as 4429 Hickory, Hammond, Indiana, and legally described as follows:

shall hereby and hereafter vest in fee simple in the sole beneficiary of decedent's Will, Florence Miller Link; that the 2005 Cadillac automobile of the decedent, bearing VIN: 1G6KD54Y75U221253, shall hereafter be held in the name of the sole beneficiary of the decedent's Will, namely, Florence Miller Link; that all accounts, including, but not limited to, all stocks, bonds, individual retirement accounts, retirement accounts, monies, cash and the balance of all funds contained in that certain account in the name of the estate and Personal Representative held by Financial Network with offices located in Highland, Indiana, shall hereafter vest in the name of the sole beneficiary of decedent's Will, namely, Florence Miller Link; and the Chase Bank Checking Account No. 180000166405 shall hereafter vest in the name of the sole beneficiary of decedent's Will, namely, Florence Miller Link; and that all other net assets of the Estate of Robert R. Miller herein shall hereafter vest in the name of the sole beneficiary of the decedent's Will, namely, Florence Miller Link.

4. That after making final distribution, the Personal Representative shall file a supplemental report indicating the same.
