**Affidavit of Heirship**

Cinda Lee Kantor, being first duly sworn upon her oath, deposes and says:

1. Affiant is the adult daughter of Paul A. Myres and Deloris M. Myres. Paul A. Myres died intestate on the 19<sup>th</sup> day of September, 2002, and Deloris M. Myres died intestate on the 4<sup>th</sup> day of February, 2003, both residents of Lake County, Indiana.

2. Paul A. Myres and Deloris M. Myres were duly and legally married at the time they acquired title as husband and wife to the following described real estate:

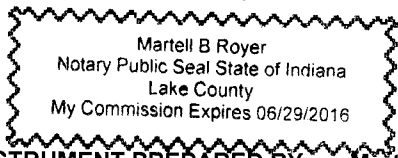
