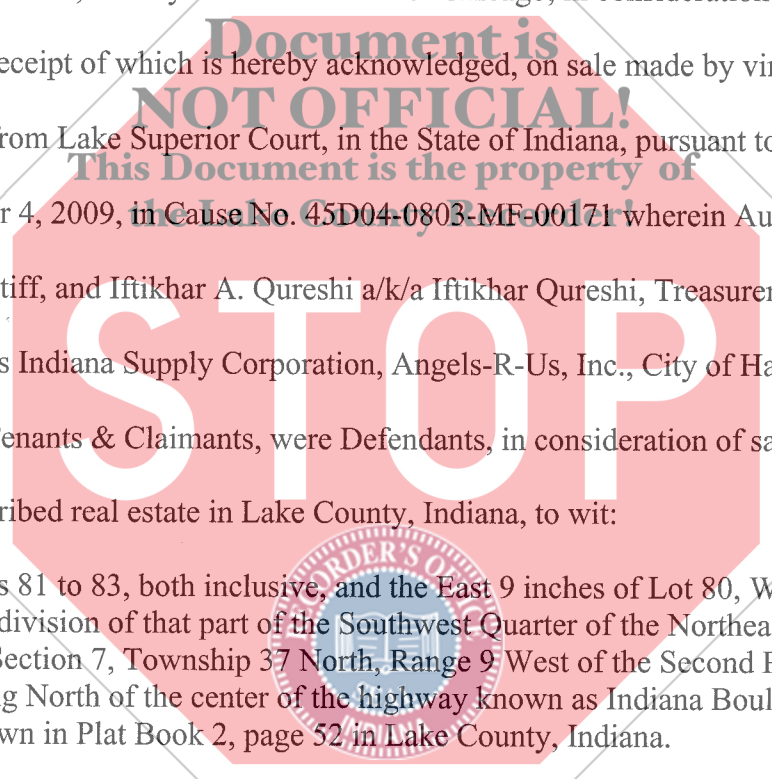
SHERIFF'S DEED

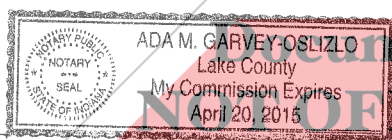
