6037 W. 29TH Place, Gary, Lake County, Indiana

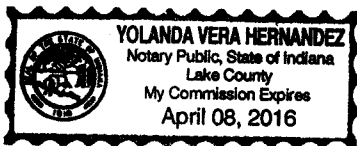
