RELEASE OF INDENTURE

WHEREAS, Hobart Multi-School Building Corporation ("Corporation"), pursuant to a Trust Indenture and Mortgage dated as of February 1, 2003 ("Indenture") between the Corporation and The Bank of New York Mellon Trust Company, N.A., as successor to Bank One Trust Company, National Association, issued its First Mortgage Bonds, Series 2003 ("Bonds"); and

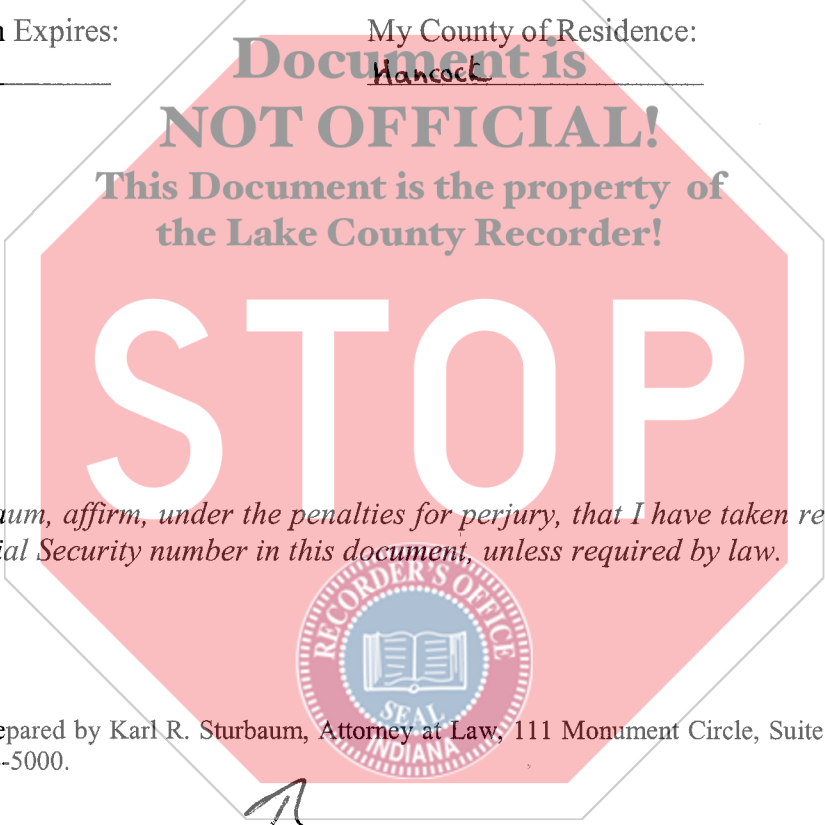
