2. This Special Power of Attorney shall be effective from the date of execution hereof until it is revoked in writing.

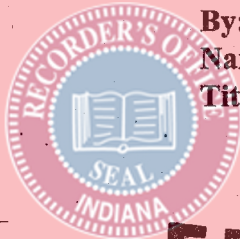
