Release and quit claim to THE TED T. and DOLORES E. CZERNIAK REVOCABLE LIVING TRUST

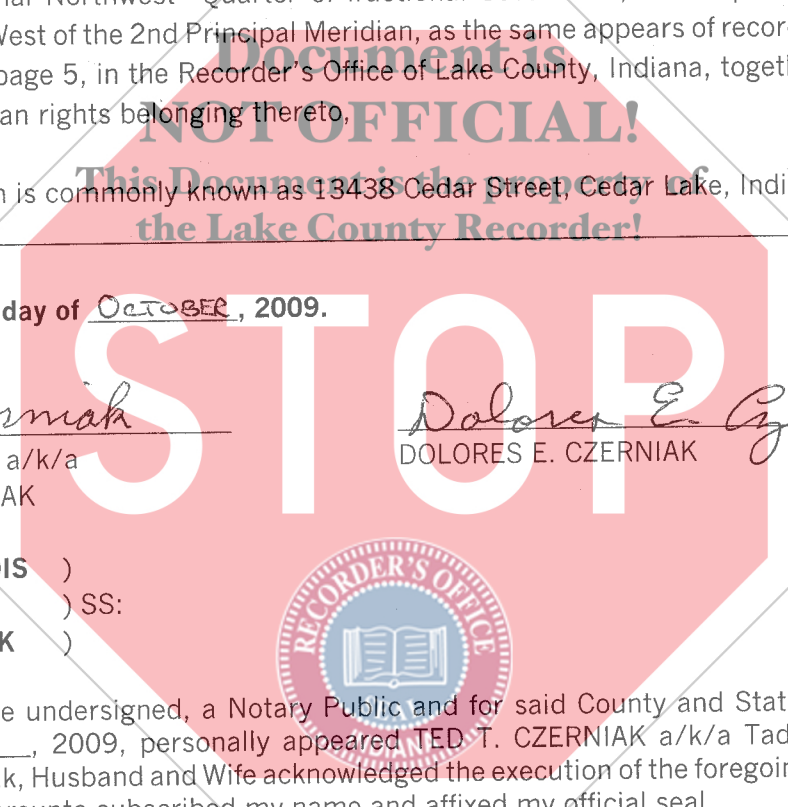

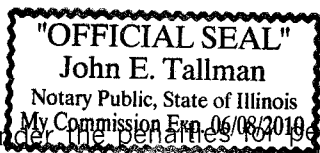
