- Shall always be subject to and limited by, and shall not defeat, render invalid or limit in any way the lien of any Mortgage or Deed of Trust permitted by this Deed, and any rights or interests provided in the Purchase Agreement for the protection of the Trustees of any such Deed of Trust or the holders of any such mortgage; and
- In the event that title to the said property or part thereof shall revest in the Grantor in accordance with the provisions of this Deed, the Grantor shall pursuant to its responsibilities under applicable law use its best efforts to re-sell the property or part thereof (subject to such mortgage liens as hereinbefore set forth and provided) to a qualified and responsible party (as determined by the Grantor) who will assume the obligation of completing the construction of a home on the property.
