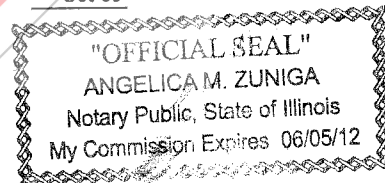

## LEGAL DESCRIPTION

Situated in the County of Lake, in the state of Indiana, to wit:

Part of the Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 19, Township 34 North, Range 8 West of the Second Principal Meridian, lying west of the center line of the Crown Point-Lowell Road more particularly described as follows:

Commencing at a point on the North line of said Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 19 and 165 feet East of the Northwest corner thereof; thence East along the North line of said Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  a distance of 68.08 feet; thence South with an interior angle of 90 degrees, a distance of 150 feet; thence West parallel with the North line of said Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 19, a distance of 66.14 feet; thence North on a line parallel to the West line of said Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 19, a distance of 150 feet to the point of beginning.
